Tá ceantair fhairsinge Ghaeltachta i gcontaetha Dhún na nGall, Mhaigh Eo, na Gaillimhe agus Chiarraí agus pobail níos lú i gcontaetha Phort Láirge, Chorcaí agus na Mí. Tá na ceantair Ghaeltachta sainithe ag orduithe Rialtais agus tá sé atitheanta ag rialtas i ndiaidh a chéile go bhfuil gá le bearta, struchtúir agus maoiniú ar leith chun cothabháil na bpobal seo a chinntíú.

Soláthraíonn an Ghaeltacht deis agus dúshlán chun leanúnachas na Gaeilge mar theanga pobail a choinneáil beo go nádúrtha. Soláthraíonn sí timpeallacht do dhaoine ar mian leo an Ghaeilge a bheith ar a dtuile acu agus tá sí mar chuid dílis agus inspioráideach den sprioc náisiúnta sochaí dhátheangach a bhaint amach.

De réir Dhaonáirimh 2011, is é daonra iomlán na Gaeltachta ná thart ar 100,000.



The Gaeltacht

The Gaeltacht covers extensive parts of counties Donegal, Mayo, Galway and Kerry and small parts of counties Waterford, Cork and Meath. Although all of the Gaeltacht population speak English, these are the only parts of Ireland where Irish is still spoken as a community language. The Gaeltacht areas are defined by Government orders and every successive government has recognised the need for specific measures, structures and funding to ensure the maintenance of these communities.


The Gaeltacht presents an opportunity and a challenge to maintain naturally the continuity of Irish as a community language. It provides the ideal environment for people who wish to become proficient in Irish and forms an integral and inspirational element of the national objective of achieving a bilingual society in Ireland.

According to the 2011 Census, the total population of the Gaeltacht was approximately 100,000.

Struchtúr Bainistíochta/Management Structure




Údarás na Gaeltachta

Is é Údarás na Gaeltachta, a bunaíodh in 1980, an t-údarás forbartha réigiúnach atá maoinithe ag an Rialtas chun forbairt teanga, chultúir, shóisialta, fhisiciúil agus eacnamaíoch na Gaeltachta a chur chun cinn. Chun na haidhmeanna sin a bhaint amach, tacáonn an tÚdarás le scéimeanna táirgiúla fostáiochta trí fhorbairt a dhéanamh ar acmhainní nádúrtha áitiúla, ar scileanna agus ar chumais fhiontraíochta, trí infheistíocht shoghluaiste a mhealladh chun na Gaeltachta agus trí thacaíocht a thabhairt do thionscainmh fhobhartha pobail. Cuidíonn sé freisin le réimse leathan de thionscainmh theanga, chultúrtha agus oideachais atá dírithe ar an nGaeilge a neartú mar phríomh-mheán cumarsáide i ngach earnáil de shaol an phobail.

Faoi Acht na Gaeltachta 2012, tugadh feidhm reachtúil don Údarás maidir le cur i bhfeidhm *Straitéis 20 Bliaín don Ghaeilge 2010-2030* sa Ghaeltacht. Sa straitéis sin leagtar béim ar phleanáil chomhtháite teanga ag leibhéal an phobail. Tacaíonn an tAcht le ról an Údarás mar phríomh-gheallsealbhóir i bhforbairt réigiúnach na Gaeltachta agus tugann sé bunús reachtúil don Údarás ó thaobh an phróisis phleanála teanga de.

Ag deireadh na bliana bhí foireann de 82 duine lonnaithe i ngréasán d'oifigí réigiúnacha sna Gaeltachtaí éagsúla ag an Údarás chun a dhualgais reachtúla a chur i bhfeidhm.



Údarás na Gaeltachta

Established in 1980, Údarás na Gaeltachta is the regional development authority funded by the Government to promote the linguistic, cultural, social, physical and economic development of the Gaeltacht. In furtherance of these aims, An tÚdarás promotes productive schemes of employment through the development of local natural resources, skills and entrepreneurial abilities and the attraction of mobile investment to the Gaeltacht. It also promotes and supports community development initiatives and a wide range of language, cultural and educational schemes aimed at strengthening the use of Irish as the principal means of communication among all sections and sectors of the community.

The Gaeltacht Act 2012 provides Údarás na Gaeltachta with a statutory function regarding the implementation of the *20-Year Strategy for the Irish Language 2010-2030* in the Gaeltacht. The strategy places emphasis on integrated language planning at community level. The Gaeltacht Act 2012 endorses Údarás na Gaeltachta's role as the principal stakeholder in the regional development of the Gaeltacht and provides a statutory foundation for the language planning process.

At year end, the organisation had a staff of 82 people based in a network of regional offices throughout the Gaeltacht to implement its statutory brief.

The Board of An tÚdarás

The Board of an tÚdarás is made up of 12 members, chairperson included. The Minister for Arts, Heritage and the Gaeltacht appoints the board members for a period not exceeding five years, five of whom are nominated by county councils from counties which include Gaeltacht areas. The Board of Údarás na Gaeltachta is responsible for the broad strategies and policies of Údarás na Gaeltachta. The Board approves investments, support schemes and the purchase and sale of assets undertaken by the authority for the purposes of enterprise development and employment creation, the promotion of the Irish language and culture, and the development of Gaeltacht communities.







Ráiteas an Chathaoirligh

Tá ról ar leith leagtha síos d'Údarás na Gaeltachta in Acht na Gaeltachta, 2012 maidir le cur i bhfeidhm *Straítéis 20 Bliain don Ghaeilge 2010-2030*. Sa Straítéis sin leagtar an bhéim ar phleanáil chomhtháite teanga ag leibhéal an phobail agus tá sprioc leagtha síos ann go n-ardófaí faoi 25% líon na gcainteoirí gníomhacha Gaeilge sa Ghaeltacht.

Le linn 2013 cuireadh dlús le hobair phleanála le feidhm a thabhairt d'Acht na Gaeltachta, 2012. Aontaíodh go mbeadh 26 Limistéar Pleanála Teanga Gaeltachta i gceist agus rinneadh sainiú iomlán de réir toghrann ar na limistéir sin.

Tús leis an phróiseas pleanála teanga

Cuireadh tús foirmeálta leis an phróiseas pleanála teanga sa Ghaeltacht i Mí na Nollag 2013 nuair a rinneadh fógraí i dtaca le trí Limistéar Pleanála Teanga Gaeltachta i gcontaetha Dhún na nGall, na Gaillimhe agus Chiarrá. Is toradh iad na fógraí sin ar obair thrí bliana a dhíriugh ar phróiseas nua pleanála teanga a chur ar bhunús reachtúil, agus is céim shuntasach chun tosaigh í seo i stair agus i dtodhchaí na Gaeilge sa Ghaeltacht.

D'oibrigh an tÚdarás i gcomhar leis an Roinn Ealaíon, Oidhreachta agus Gaeltachta agus le Foras na Gaeilge leis an bhunsraith riarracháin agus na córais éagsúla oibre, atá mar chuid den phróiseas, a leagan síos. Forbraíodh

agus aontaíodh próiseas le heagraíochtaí a roghnú le dul i mbun pleannanna teanga a ullmhú sna Limistéir Pleanála Teanga. Is é an cuspóir a bheidh ag na pleannanna teanga ná cur le húsáid na Gaeilge sna limistéir lena mbaineann siad i réimsí an phobail agus an teachlaigh, i réimsí oideachais, sóisialta, gnó agus poiblí. Tá an tÚdarás freagrach as eagraíochtaí a roghnú le pleannanna teanga a ullmhú agus a fheidhmiú sna limistéir éagsúla.

Déanfar deich Limistéar Pleanála Teanga eile a fhógairt i rith 2014 agus beifear ag lorg iarratas ó eagraíochtaí sna limistéir sin de réir mar a dhéantar iad á fhógairt.

Próiseas dúshlánach

Tá dúshláin ag baint leis an phleanáil teanga agus beidh an tÚdarás ag obair go dlúth leis na pobail Ghaeltachta agus le páirtithe leasmhara eile le pleannanna éifeachtacha teanga a fhorbairt a mbeidh mar aidhm acu pobal inmharthana Gaeilge a chinntíú sa Ghaeltacht.

Aithníonn pobal na Gaeltachta go bhfuil creimeadh leanúnach ag tarlú don Gaeilge mar theanga theaghlaigh agus phoball sa



Chairperson's Statement

The Gaeltacht Act 2012 sets out Údarás na Gaeltachta's specific role in relation to the implementation of the *20-Year Strategy for the Irish Language 2010-2030*. The Strategy places emphasis on integrated language planning at a community level and sets a target to increase the level of active Irish speakers in the Gaeltacht by 25%.

During 2013, initial measures to give statutory effect to the Gaeltacht Act 2012 were developed. It was agreed that the Gaeltacht would consist of 26 language planning areas, and those areas were defined based on electoral divisions.

The language planning process begins in the Gaeltacht

The language planning process in the Gaeltacht was formally launched at the end of 2013 when notices in respect of three Gaeltacht Language Planning Areas in counties Donegal, Galway and Kerry were announced. These notices were the result of three years' work, which aims to give legislative effect to a new language planning process, and represents significant development in the history and future of the Irish language in the Gaeltacht.

During 2013 an tÚdarás worked closely with the Department of Arts, Heritage and the Gaeltacht and with Foras na Gaeilge on the development of an administrative

framework and procedures that form part of the planning process. The process to select the organisations that

will prepare language plans for the Language Planning Areas was developed and approved. The aim of the language plans is to increase the use of the Irish language in their relevant areas in community and family settings, as well as in education, social, business and public areas. An tÚdarás has been tasked with the selection of the lead organisations whose responsibility will be to prepare and implement the language plans for the various areas.

Ten other Language Planning Areas will be announced during 2014 and applications will be sought from organisations in those areas as they are announced.

A challenging process

Language planning is a challenging process and an tÚdarás will work closely with the Gaeltacht communities and with other stakeholders to develop effective language plans that seek to support sustainable Irish language communities within the Gaeltacht. The Gaeltacht community recognises that the Irish language is being constantly eroded as a family and community language in the Gaeltacht, and that the language is at a crisis

Ghaeltacht agus, dá bhrí sin, go bhfuil géarchéim teanga i mórán ceantar Gaeltachta. Is próiseas casta é an próiseas pleánala teanga, agus caithfear tabhairt faoin obair dhúshlánach seo le comhoibriú agus rannpháirtíocht an phobail, le comhoibriú ón earnáil dheonach, ón earnáil phoiblí agus ón earnáil phríobháideach, agus oibriú as lámha a chéile chun tacú leis an Ghaeilge a chur chun cinn sna ceantair éagsúla.

Fostaíochta agus Tionchar Eacnamaíochta

Cruthaíodh 611 post nua i gcliantchomhlachtaí Údarás na Gaeltachta in 2013. Bhí beagnach 7,650 post i gcliantchomhlachtaí an Údarás ag deireadh na bliana (comhdhéanta de 6,969 post lánaimseartha agus 680 post páirtaimseartha). Is údar mór dóchais é go raibh an líon ba lú cailleannais post le tríocha bliain i gcliantchomhlachtaí Gaeltachta le linn 2013.

Is í an earnáil easpórtála atá ina príomh-thiománaí in athshlánú na fostáiochta agus i bhfás eacnamaíochta sa tir, agus anuraidh mhéadaigh an díolachán easpórtála i gcliantchomhlachtaí an Údarás go €464 milliún. Is fianaise í an méadú atá tagtha ar an easpórtáil iomlán, mar chéadatán de dhíolachán, ó 45% in 2008 go 59% in 2012, go bhfuil na comhlachtaí Gaeltachta ag diríú cuid mhór ar an easpórtáil. Tugann taighde a rinne Indecon International Economic Consultants in 2013 le fios go bhfuil tionchar suntasach ag cliantchomhlachtaí an Údarás ar gheilleagar na hÉireann, agus meastar go gcuireann siad luach iomlán de thart ar €1.5 billiún leis.

point. Language planning is a complex process, and this challenging work must be undertaken with co-operation and participation of the community, with the co-operation of the voluntary sector, the public sector and the private sector, all working together to support the promotion and usage of the Irish language in the Gaeltacht.

Employment and Economic Impact

Údarás na Gaeltachta client companies created 611 new full-time jobs last year. At year end, total employment in Údarás client companies stood at c. 7,650 (of which 6,969 were full-time jobs and 680 were part-time jobs). Significantly, 2013 saw the lowest rate of job losses in thirty years in Gaeltacht client companies.

The export sector has been the key driver in restoring employment and growth in the country and last year saw export sales increase to €464 million in Údarás-supported companies. The increasing focus by these companies on export markets is evidenced by the finding that since 2008, the ratio of exports to overall sales across the Údarás client-base has increased year-on-year from 45% to 59% in 2012. Research carried out by Indecon International Economic Consultants in 2013 indicates that Údarás client companies continue to make a significant contribution to Ireland's economy, with the overall value to the Irish economy estimated to be in the region of €1.5 billion.

Ag Cothú Fointair agus ag Cruthú Fostaíochta

Iomas go mbeidh sé in ann a theacht i dtí ar dheisceanna nua cruthaithe fostáiochta, teastaíonn infreastruchtúr gnó ón Údarás a bheidh in oiriúint do riachtanais a chliant agus do na gnólachtaí nua a bheidh ag teacht chun cinn. Ceann de na constaicí is mó a bhaineann le forbairt bhreise fiontraíochta agus le cruthú fostáiochta sa Ghaeltacht is ea an easpa infreastruchtúr oiriúnach don ghnó. In ainneoin an rathúnais a bhí sa tir suas go dtí 2006, is beag samplaí atá ann d'infheistíocht ón earnáil phríobháideach in infreastruchtúr ná saoráidí nua-aimseartha tionsclaíocha/fointair i gceantair thuaithe, ná sa Ghaeltacht ach go háirithe.

Sé taithí an Údarás ná go bhfuil sé níos éasca infheistíocht fointair a mhealladh nuair a bhíonn fáil ar fhoirgnimh nua-aimseartha, d'ardchaighdeán atá réidh le húsáid. Ar an bhunús sin, tá athfhorbairt déanta ar líon teoranta d'fhoirgnimh an Údarás le blianta anuas. Tá na foirgnimh sin ionann agus a bheith lán faoin tráth seo. Léiríonn an t-eileamh sin an gá atá le breis infheistíochta chaipítil sa Ghaeltacht le go mbeifear ábalta tuilleadh infheistíochta a mhealladh isteach. Tá athfhorbairt agus uasghrádú ar mhaoin ghnó an Údarás riachtanach le cinntí go mbeidh rath ar fheidhm forbartha fointair agus cruthú fostáiochta na heagraíochta agus leanfaidh an tÚdarás air ag iarráidh teacht ar bhealaí leis an athfhorbairt seo a mhaoiniú.

Fostering Enterprise and Job Creation

In order to harness employment creation opportunities, an tÚdarás requires a business infrastructure appropriate to the needs of existing clients and emerging start-ups. One of the main impediments to further enterprise stimulation and job creation in the Gaeltacht is the lack of adequate business infrastructure. In spite of the relative prosperity experienced in Ireland up to 2006, there are few examples of private sector investment in modern industrial/enterprise infrastructure and associated facilities in rural areas, outside of key centres of population, and the Gaeltacht in particular.

Experience has shown that enterprise investment is easier to attract where contemporary, state-of-the-art, ready-to-occupy business premises are available. On this basis, a limited number of An tÚdarás' industrial-type properties have been redeveloped in recent years. These facilities are now close to full capacity. This positive uptake underpins the need for further capital investment to help place the Gaeltacht in a position to attract further inward investment. The redevelopment and upgrade of An tÚdarás' business property portfolio is key to the success of its enterprise development and employment creation strategy, and the Authority will be seeking ways to fund the redevelopment of its property portfolio.

Forbairt Fiontraíochta

Tugann an tÚdarás faoi réimse leathan gníomhaíochtaí fiontraíochta agus forbartha chun a fheidhmeanna i dtaca le cruthú agus caomhnú fostáiochta sa Gaeltacht a bhaint amach. Tá na fointair a fhagheann tacaíocht ag feidhmiú in earnálacha ar nós eolaíochtaí beatha (bithealighis agus cógaisíocht), teicneolaíocht faisnéise agus cumarsáide, déantúsaíocht nideoige (earraí innealtóireachta agus tomhaltais), closamhairc agus na meáin dhigiteacha, turasóireacht, fointair mhara agus theangabhunaithe.

Cruthaídh 611 post nua i gcliantchomhlachtaí Údarás na Gaeltachta in 2013. Bhí 7,649 post i gcliantchomhlachtaí an Údarás ag deireadh na bliana, comhdhéanta de 6,969 post lánaimseartha agus 680 post páirtaimseartha. Nuair a thógtar lón na bpost a cailleadh san áireamh, bhí glanmhéadú 96 post i gceist.

Le blianta anuas, tá Údarás na Gaeltachta dírithe ar phorbairt a dhéanamh ar líon earnálacha ar a n-áirítear acmhainní nádúrtha agus mara, eolaíochtaí beatha, teicneolaíocht faisnéise, bia, déantúsaíocht nideoige, innealtóireachta agus tráchtearraí ardluacha eile atá intrádála go hidrnáisiúnta. Tháinig fás ar chomhlachtaí Gaeltachta sna hearnálacha sin, i dtéarmaí díolacháin agus i gcruthú fostáiochta, i rith na bliana. Is údar mór dóchais é go raibh an líon ba lú caillteanais post le tríocha bliain i gcliantchomhlachtaí Gaeltachta le linn 2013. Tá an laghdú leanúnach ar an ráta caillteanais post le roinnt blianta anuas ina léiriú dearfach ar an dóigh a bhfuil comhlachtaí Gaeltachta tar éis a mbonn fostáiochta a bhuanú le blianta anuas agus iad in ann díriú anois ar bhorradh a chur faoina bhfiontair agus an eacnamaíocht ar tí a theacht chuici féin.

Is í an earnáil easpórtála atá ina príomh-thiománaí in athshláinú na fostáiochta agus i bhfás eacnamaíochta sa tir, agus anuraidh mhéadaigh an díolachán easpórtála i gcliantchomhlachtaí an Údarás go €464 milliún.

Enterprise Development

An tÚdarás undertakes a wide range of enterprise and development activities in order to fulfil its functions in relation to the creation and maintenance of employment in the Gaeltacht. The enterprises supported operate in sectors such as life sciences (biomedical and pharmaceutical), information and communications technology, niche manufacturing (engineering and consumer goods), audio-visual and digital media, tourism, marine and language-based enterprises.

A total of 611 new jobs were created in Údarás-assisted companies in 2013. At year end, total employment in Údarás client companies stood at 7,649, of which 6,969 were full-time jobs and 680 were part-time jobs. When job losses are taken into consideration, there was a net increase of 96 jobs overall.

In recent years, Údarás na Gaeltachta has focused on developing a key number of sectors which include natural and marine resources, life sciences, ICT, food, niche manufacturing, engineering and other high-value, internationally tradeable commodities. Gaeltacht companies in these sectors experienced growth during the year, both in terms of sales and in employment creation. Significantly, 2013 also saw a record low in the rate of job losses in the Gaeltacht. The steady fall in the rate of job losses over the past number of years is a positive indication of how Gaeltacht companies have stabilised their employment base and can now look to growing their enterprise as the economy begins to recover.

The export sector has been the key driver in restoring employment and growth in the country and last year saw export sales increase to €464 million in Údarás-supported companies.

Cruthófar breis agus leath de na poist sin i ghnólachtaí nua, agus cruthófar an chuid eile acu i gcliantchomhlachtaí reatha de réir mar a bheidh siad ag forbairt a ngnótháí. Táthar ag súil go dtiocfaidh na poist sin chun cinn in 2014 agus sna blianta ina dhiaidh sin nuair atá na tograí faoi lán seoil.

Maoiniú Stáit

Job Approvals

In 2013 Údarás na Gaeltachta approved projects which are expected to create a further 560 new jobs and lead to an overall projected investment of €44 million in Gaeltacht companies. Over half of these jobs will be created in new start-up enterprises, with the remainder generated by existing client companies as they further expand their businesses. These jobs are expected to come on stream throughout 2014 and in subsequent years.

State Funding

Grant assistance and capital expenditure approved by An tÚdarás in 2013 for employment creation and other development projects, for education and training, and for infrastructure involved an overall State investment of c. €14.5 million.

Research and Development

An tÚdarás continued to place emphasis on research and development expenditure as it assisted its client companies to develop their competitive capacities. In 2013, some €1.25 million was approved in research and development type grants and grants for the development of market research skills. Total grants paid for research and development activities and the development of market research skills amounted to €972,000 during the year. An tÚdarás, in co-operation with Enterprise Ireland, is committed to working with companies through the national Research and Development and Innovation

Léiríonn an costas in aghaidh an phoist an caiteachas deontais ar chaipiteal, fhostaíocht, taighde agus forbairt agus ar oiliúint shainiúil a íocatar le claintchomhlachtaí ach ní áiríonn sé deontais FIFG (Ionstraim Airgeadais do Threoir Lascaireachtaí) ná T&F&N. Punann Maoine

Ag deireadh 2013 bhí punann leathan maoine le hachar os cionn 239,000 méadar cearnach á bhainistiú ag Údarás na Gaeltachta i seacht gcontae éagsúla. Bhí 68% den spás faoi thionónachtáí nó in áirithe. Bhí timpeall 30% den spás folamh suas go caighdeán sásúil agus ar fáil do thionóntaí úra. Bhí gá le hathchóiriú a dhéanamh ar an méid spáis a bhí fágtha agus bhí sé mar sprioc go mbeadh leath den spás folamh sin ar an gclár caipítíle

(R&D&I) scheme to strengthen the research and innovation base of the enterprise sector.

Cost per Job

The grant cost per job for 2013 was €4,568 and the average cost per job over the past five years was €10,275. The cost per job figure for 2013 is unusually low and is mainly due to substantially reduced grant-aid budget and new jobs coming on-stream as a result of support paid in previous year. The cost per job reflects grant payments towards capital, employment, research and development and specific training paid to client companies but excludes FIFG (Financial Instrument for Fisheries Guidance) and R&D&I funding. Other expenditure on training and education is excluded as there is no direct link between a substantial proportion of the expenditure on third level education courses and lifelong learning support schemes and the current year job creation programmes.

Property Portfolio

At the end of 2013 Údarás na Gaeltachta was managing a substantial property portfolio of over 239,000 square metres located throughout the Gaeltacht in seven different counties. A total of 68% of the property space was either occupied by enterprises or reserved for new tenants. Approximately 30% of the vacant property was of suitable standard and available to lease to new industry/businesses. The remaining unoccupied property required

Le linn na bliana ceadaíodh maoiniú le Lárionad Forbartha Gaeilge agus Gaeltachta, a chosnóidh €3.4 milliún, a phorbairt i mBaile an Fheirtéaraigh i gContae Chiarraí ar shuíomh de chuid Údarás na Gaeltachta. Tá Údarás na Gaeltachta, An Roinn Ealaón, Oidhreachta agus Gaeltachta agus Comharchumann Forbartha Chorca Dhuibhne Teo i gcomhpháirtíocht agus ag maoiniú an togra nua seo.

Mar chuid den Lárionad Forbartha seo, ina mbeidh achar de c.1,400 méadar cearnach, beidh oifigí agus áiseanna nua do Chomharchumann Forbartha Chorca Dhuibhne Teo; ionad tacáiochta teaghlaigh ina mbeidh áiseanna nua don naíonra agus seirbhísí réamhscoile; spás oiliúna; agus trí aonad fiontraíochta de chuid an Údarás. Is é Údarás na Gaeltachta a bheidh freagrach as an phorbairt

substantial renovation, half of which is included in the Údarás 2014-2016 capital programme for refurbishment/redevelopment and will be undertaken subject to funding being available. A significant amount of capital investment is required to bring these industrial-type buildings to the standards required by today's modern enterprises.

During 2013, refurbishment/renovation works were carried out on buildings on the Gaoth Dobhair Business Park, in Cill Chárthaigh and Mín an Aoire in County Donegal; in Baile an tSagairt, An Cheathrú Rua and on Inis Oírr in County Galway; and on Oileán Chléire and in Béal Átha an Ghaorthaidh in County Cork. The property disposal programme continued apace and €446,878 was realised from the sale of property during 2013.

Funding for the development of an Irish Language and Gaeltacht Development Centre, costing €3.4 million, on an Údarás na Gaeltachta site was approved for Baile an Fheirtéaraigh, Co. Kerry. Údarás na Gaeltachta, the Department of Arts, Heritage and the Gaeltacht and Comharchumann Forbartha Chorca Dhuibhne Teo are involved in the partnership and funding of this project.

The development centre, which will be c. 1,400 square metres, will include offices and new facilities for Comharchumann Forbartha Chorca Dhuibhne Teo; a language support centre comprising new pre-school facilities and services; a training centre; and three Údarás na Gaeltachta enterprise units. Údarás na Gaeltachta will

Education, Community and Cultural Activities

An tÚdarás recognises that it has an important role in supporting the Gaeltacht culture and community through the provision of educational, social, cultural services and facilities in the Gaeltacht so that the Gaeltacht community may enjoy a similar quality of lifestyle to its fellow citizens.

To achieve these objectives, An tÚdarás supports and administers a range of initiatives and schemes in relation to education and training, community development, the arts and Irish culture.

Education and Training

During 2013, funding was provided for local training and education development initiatives in all Gaeltacht areas aimed at realising the community and enterprise development objectives of An tÚdarás.

These education and training development schemes support the upgrading and retraining of the Gaeltacht workforce and provide training opportunities for people entering the labour market for the first time through

An tÚdarás provides funding to a number of third level institutions which have Gaeltacht areas within their catchment regions, for the provision of accredited diploma, higher diploma, degree and post-graduate courses.

During 2013:

- A total of 28 apprentice scholarships were awarded in various trades under the Apprenticeship Scheme. At year end there were 73 apprentices at various stages of their training on Údarás-funded apprenticeships;
- 27 people received training under the Management Development Scheme and Work Experience Scheme which aim to provide practical work experience for third level graduates and/or people seeking back to work experience;
- Funding was provided for a Diploma Course in Language Planning and Preservation delivered by Acadamh na hOllscolaíochta Gaeilge. This two year course, which began in 2013, aims to give participants an understanding of language preservation strategies and the key concepts of language planning. 106 students registered for the course;

- Eagraíodh réimse éagsúla cúrsáid agus tionscnaimh oiliúna dírithe ar fhiontraí in ábhair ar nós forbairt scileanna gnó agus fiontraíochta, tosaigh do ghnó féin, forbairt pobail agus an turasóireacht chultúrtha;
- Leanadh de mhaoiniú a sholáthair d'Institiúid Teicneolaíochta Phort Láirge i gcomhar le Nemeton Teo chun an cursa Ard-Dioplóma i Léiriú Teiliúise a reáchtáil sa Rinn, Contae Phort Láirge; d'Institiúid Teicneolaíochta na Gaillimh-Mhaigh Eo i gcomhar le Europus Co Teo. le cursa Ard-Dioplóma/Msc i nGaeilge Fheidhmeach agus Aistriúchán a reáchtáil i gCarna, Contae na Gaillimhe agus d'Áras Shorcha Uí Ghuairim le Dioplóma Ríomhairesca don Riarachán Gnó a reáchtáil i gCarna, Contae na Gaillimhe.

- Funding was provided to the Diploma in Teaching Irish to Adult Learners course offered by The Language Centre in the National University Ireland, Maynooth, where emphasis is placed on teaching practices in the classroom and on practical support for the teacher;
- Various training courses and programmes were organised during the year directed at entrepreneurs and focused on developing business skills and business start-ups, community development and cultural tourism;
- Funding continued to be provided to the Waterford Institute of Technology in association with Nemeton Teo. to deliver the Higher Diploma in television and media in An Rinn, County Waterford; to the Galway-Mayo Institute of Technology in association with Europus Co Teo. to deliver the Higher Diploma/Msc in applied Irish in Carna, County Galway and to Áras Shorcha Uí Ghuairim to deliver the Diploma in computing for business administration in Carna, County Galway.

Forbairt Pobail

Tá forbairt pobail mar chuid dílis d'fheidhmeanna Údarás na Gaeltachta agus chuige sin tá gníomhachtaí ar leith ar bun aige atá thíos ar fhorbairt pobail na Gaeltachta mar a leanas:

Scéimeanna Fostaíochta Sóisialta

Déanann Údarás na Gaeltachta bainistiú agus riarrachán ar an Scéim Fostaíochta Pobail, an Scéim Shóisialta Tuaithe, Tús agus Tús Nua. Déanann an Roinn Coimirce Sóisialaí maoiniú ar na scéimeanna fostaíochta sóisialta a bhfuil ról tábhachtach acu i soláthar taithí oibre agus oiliúna do phobail Ghaeltachta. In 2013, fostaíodh breis agus 1,000 rannpháirtí agus 49 maor i 49 scéim ar fud na Gaeltachta. I rith na bliana, thosaigh breis agus 300 rannpháirtí nua ar na scéimeanna agus chríochnaigh breis agus 260 rannpháirtí a gclár. Meastar go bhfuil fostaíocht faighe ag 30% dióibh sin a chríochnaigh a gclár. Tá na scéimeanna fostaíochta sóisialta seo lárnach i bhforbairt an phobail agus i gcothabháil gníomhaíochtaí Gaeilge sa Ghaeltacht.

Na hEagrasí Phobail

Tá maoiniú tríd an Scéim Deontas Reáchtala á chur ar fáil ag Údarás na Gaeltachta do 30 eagras pobail (comharchumainn agus comhlachtaí pobalbhunaithe) sa Ghaeltacht. Cuireann na heagrasí phobalbhunaithe seo, ina bhfuil 85 duine fostaithe, cláir leathana i bhfeidhm a chlúdaíonn gníomhaíochtaí forbartha pobail, bainistiú scéimeanna/tionscnamh agus caomhnú agus neartú

na Gaeilge agus an chultúir Ghaelaigh. Tá plean oibre ag gach eagraíocht agus biónn spriocanna sonracha aontaithe leis an Údarás mar chuid den chomhaontú ar mhaoiniú.

Scéim Fiontar Pobail

Cuireadh maoiniú os cionn €40,000 ar fáil tríd an Scéim Fiontar Pobail do 30 eagraíochta/coiste pobail chun cuidiú leo gníomhaíochtaí forbartha pobail a chur chun cinn agus chun oiliúint a chur ar fáil dóibh le tacú leo pleannanna forbartha a ullmhú.

Muintearas Teo

Tá Muintearas Teo, atá á mhaoiniú chun cuspoír áirithe oideachais, teanga agus forbartha daonna a bhaint amach, ag cur béime den chuid is mó ar mhaolú ar an míbhuntáiste sa soláthar oideachais/oiliúna Gaeltachta, ar chothromaíocht deiseanna a bhaint amach don Ghaeltacht agus ar an nGaeilge mar mheán teagaisc san oideachas Gaeltachta a threisiú. Áiritear na réimsí seo a leanas mar phríomhréimsí oibre an chomhlachta - luathfhorbairt an linbh, an réimse oideachais, an óige, cúrsai nuatheicneolaíochta, cumarsáide agus oideachas fadsaíil pobail. I gcuideachta leis an Údarás, cuireann an Roinn Oideachais agus Scileanna, an Roinn Ealaón, Oidhreachta agus Gaeltachta, SOLAS, POBAL agus cláir de chuid an Aontais Eorpaidh foinsí maoinithe eile ar fáil do réimsí éagsúla tionscadail atá á n-eagrú aige. Cheadaigh Údarás na Gaeltachta maoiniú de €400,000 do Muintearas in 2013.

Community Development

Údarás na Gaeltachta recognises that community development is a core element of the development process and it administers the following schemes in the Gaeltacht:

Social Employment Schemes

Údarás na Gaeltachta manages and administers the Community Employment Scheme, the Rural Social Scheme, Tús and the Jobs Initiative. These social employment schemes, which are funded by the Department of Social Protection, play an important role in providing work experience and training for Gaeltacht communities. In 2013, over 1,000 participants and 49 supervisors were involved in 49 schemes throughout the Gaeltacht. During the year, over 300 new participants were placed on these schemes and over 260 participants completed and exited their programme. It is estimated that 30% of those that exited the programmes are now in employment. These social employment schemes are central to community development and language maintenance programmes and activities in the Gaeltacht.

Community Organisations

An annual administration grant was paid to 30 community organisations (co-operatives and community-based companies) throughout the Gaeltacht under the Community Co-operatives Administration Grant Scheme.

These community-based organisations, which employ 85 people, implement extensive work programmes throughout the Gaeltacht including the maintenance and preservation of the Irish language and culture. A programme of work is agreed annually with each organisation as part of the funding agreement.

Community Enterprise Scheme

Funding in excess of €40,000 was provided to 30 community organisations to support the development of small scale community development activities.

Muintearas Teo

Funded to implement educational, language and personal development programmes, Muintearas Teo's focus is largely on reducing disadvantage in Gaeltacht education/training provision, on achieving equality of opportunities for the Gaeltacht communities and reinforcing Irish as a teaching medium in Gaeltacht education. The company's primary focus is on early childhood development, education, youth, new technology and communications as well as the provision of lifelong learning courses. In addition to funding from Údarás na Gaeltachta, Muintearas also receives funding from the Department of Education and Skills, the Department of Arts, Heritage and the Gaeltacht, SOLAS, POBAL and a number of European Union programmes for various initiatives it administers. Údarás na Gaeltachta approved €400,000 in funding to Muintearas in 2013.

Daoine Scothaosta

Mar chuid de pholasai forbartha sóisialta agus caomhnaithe teanga na heagráiochta cuireadh tacaíocht ar fáil, tríd na scéimeanna fostáiochta, d'ionaid lae chun tacú leo seirbhísí breise a sholáthar don aosach. Reáchtáladh réimse de chúrsaí i gcúram aosaigh i gcomphpháirtíocht le Feidhmeannacht na Seirbhise Sláinte, Coiste Gairmoideachais na Gaillimhe agus Cumann Cúramóiri na hÉireann.

Na hEalaíona

Déanann Údarás na Gaeltachta agus An Chomhairle Ealaíon cómhaoiniú ar chlár forbartha agus cothaithe na n-ealaíon traidisiúnta agus comhaimseartha tríd an fhochuideachta Ealaín (na Gaeltachta) Teo. Cheadaigh Údarás na Gaeltachta maoiniú de €335,000 d'Ealaín (na Gaeltachta) Teo in 2013. Tá triúr áisisitheoirí réigiúnacha fostaithe ag an gcomhlacht leis an gclár a chur i bhfeidhm.

Buaiceanna 2013

Le linn 2013 cuireadh tacaíocht ar fáil do 145 togra tríd Ealaín (na Gaeltachta) Teo mar a leanas:

- Scéim Chleachtas na nEalaíon: scéim faoinar tugadh tacaíocht do dhaoine aonair nó d'eagrais ar mian leo tionscnamh ealaíon a fhorbairt. Ceadaíodh tacaíocht do 15 tionscnamh in 2013 ar a n-áirítear tionscnaimh dhrámaíochta, tionscnaimh litríochta, tionscnaimh amharcealaíon agus tionscnaimh idirdhisciplíneacha, le buiséad iomlán de €52,000.
- Scéim na bhFéilte: scéim faoinar tugadh tacaíocht do dhaoine aonair nó d'eagrais ar mian leo féilte ealaíon a fhorbairt. Cuireadh tacaíocht ar fáil do 19 féile ealaíon in 2013 le buiséad iomlán de €83,000.
- Scéim Sparánachta d'Ealaíontóir: scéim faoinar tugadh deis d'ealaíontóirí aonair iarratas a dhéanamh ar mhaoiniú a chuirfidh ar a gcumas forbairt a dhéanamh ar a gceird. Cuireadh tacaíocht ar fáil do 34 ealaíontóir in 2013, le buiséad iomlán €50,000.



The Elderly

As part of the organisation's social development and language maintenance functions, support was provided, through the social employment schemes, to day-centres to enable them to deliver additional services for the elderly. A number of carers' training courses were organised in association with the Health Service Executive, the Vocational Education Committee, Galway, and the Carers' Association of Ireland.

The Arts

Údarás na Gaeltachta and the Arts Council jointly fund a wide range of traditional and contemporary arts initiatives and projects which are delivered by the Údarás subsidiary company Ealaín (na Gaeltachta) Teo. Údarás na Gaeltachta approved €335,000 in funding to Ealaín (na Gaeltachta) Teo in 2013. The company employs three regional arts facilitators who implement the programme.

2013 Highlights

During 2013, support was provided to 145 arts initiatives through schemes facilitated by Ealaín (na Gaeltachta) Teo which are detailed below:

- The Arts Development Scheme: Provides assistance to individuals or organisations wishing to develop arts projects. Support was provided to 15 initiatives in 2013 including drama, literature, visual and interdisciplinary arts projects amounting to a total budget approval of €52,000.
- The Arts Festivals Scheme: Provides support to individuals and organisations to develop arts festivals. Funding was approved for 19 Gaeltacht arts festivals in 2013 amounting to a total budget approval of €83,000.
- The Bursary Scheme for Artists: Provides support to individual artists to assist them to develop their skills. Assistance was approved for 34 artists in 2013 amounting to a total budget approval of €50,000.

- Scéim na bPríomhréimsí: scéim faoinar ndéantar forbairt straitéiseach ar ghnéithe éagsúla a chuirfidh le hinfreastruchtúr na n-ealaíon ar bhunús fadtréimhseach. Ceadáodh tacaíocht do 11 thogra faoin scéim seo in 2013 le buiséad iomlán de €230,000.
- Scéim Síol: scéim faoinar tugadh tacaíocht do dhaoine aonair agus do ghrúpaí ar suim leo miontionscadal nó togra tosaíochta ealaíon a fhorbairt. Cuireadh tacaíocht ar fail do 66 acu seo in 2013 le buiséad iomlán de €25,000.
- Forbraíodh *Stratéis d'Fhorbairt na nEalaíon 2013-2016* agus aontaíodh an straitéis ag leibhéal boird an Údarás agus an Chomhairle Ealaíon.
- D'eagraigh Ealaín (na Gaeltachta) Teo fóram tras-Eorpach ealaíne i nDaingean Uí Chúis i mí Mhárta 2013 dar teideal 'Tír a Mór'. D'fhreastal ealaontóirí agus eagraíochtaí compháirtíochta ó Albain, an Bhléatain Bheag, an Ísiltír, an Ghailís, Tír na mBascach, Oileán Fharó agus ón Ghaeltacht le smaointe, mianta agus ábhair spéise a roinnt agus lónraí nua a fhorbairt as a d'fheadfadh comhoibriú praiticiúil Eorpach a eascairt.
- Bhí Ealaín (na Gaeltachta) Teo. lárnach i n-eagrú Tionól na gComharsan Ceilteach i Sabhal Mòr Ostaig, Oileán Sciatáinach, Albain i mí Mheitheamh. Tionól ealaíne agus cultúrtha ab é ar a raibh freastal á dhéanamh ag lucht cruthaitheach na gcríoch Ceilteach as Albain, an Bhléatain Bheag agus Éirinn. Rinneadh ceiliúradh ar chuid den obair atá bainte amach ag an gcompháirtíocht le cúpla bliain anuas, mar aon le plé agus pleánáil ar fhéidearthachtaí nua do na comharsain sa todhcháí.
- Ghlac eagraíochtaí Ghaeltachta páirt lárnach sa mhórfeile náisiúnta 'Oíche Chultúir' don cheathrú bliain as a chéile. Eagraíodh breis agus 30 imeacht ar fud na Gaeltachta mar chuid den mhórthaispeántas in 2013.
- Le tacaíocht ó Ealaín na Gaeltachta agus Foras na Gaeilge bhunaigh an t-ealaontóir Nuala Ní Fhlathúin an suíomh idirlín Nua-Ealaín. Is togra é Nua-Ealaín a dhéanann iarracht an bhearna idir an Ghaeilge agus na físealaíona a lónadh, spéis agus rannpháirteachas an phobail sna físealaíona a chothú agus na gréasáin atá ann cheana féin a láidriú.
- I 2013 rinneadh athdhearadh iomlán ar shuíomh idirlín www.ealain.ie, agus rinneadh forbairt ar uirlisí meáin shóisialta. Eagraíodh roinnt cúrsaí traenála d'ealaontóirí i gcúrsaí cumarsáide agus caidreamh poiblí.

- The Main Activities Scheme: This scheme allows for the strategic development of various projects that aim to enhance the arts infrastructure in the long term. Assistance was approved for 11 projects amounting to a total budget approval of €230,000.
- The 'Síol' Scheme: Offers assistance to individuals and groups interested in developing small arts projects or events. Support was approved for 66 initiatives, amounting to a total budget approval of €25,000.
- A *Strategy for the Development of Arts in the Gaeltacht 2013-2016* was developed, and the strategy was approved by the Board of An tÚdarás and the Arts Council.
- Ealaín (na Gaeltachta) Teo organised a trans-European arts forum, entitled 'Tír a Mór', in Daingean Uí Chúis in March 2013. Artists and partnering organisations from Scotland, Wales, Switzerland, Galicia, the Basque country, Faroe Islands and the Gaeltacht attended the event where opinions, aspirations and interests were discussed and new networks from which practical European cooperation could grow were developed.

- Ealaín (na Gaeltachta) Teo. was central in organising Tionól na gComharsan Ceilteach in Sabhal Mòr Ostaig on the Isle of Skye, Scotland in June. The arts and culture convention was attended by creative groups from Celtic regions: Scotland, Wales and Ireland. Projects completed by the partnership in recent years were commended and the possibilities of future collaborations in the future were discussed.
- Gaeltacht organisations were central in the Culture Night Festival celebrations for the fourth year in a row. Over 30 events were organised throughout the Gaeltacht as part of the 2013 event.
- Artist Nuala Ní Fhlathúin established the Nua-Ealaín website, with support from Ealaín na Gaeltachta and Foras na Gaeilge. Nua-Ealaín is a new project that attempts to bridge the gap between the Irish language and the visual art, cultivate the public's interest and participation in visual art and strengthen established networks.
- Ealaín (na Gaeltachta) Teo's website, www.ealain.ie was redesigned and new social media tools were developed. A number of training courses in communications and public relations were organised for artists.

Gníomhaíochtaí Gaeilge

Irish Language Activities



Gníomhaíochtaí Gaeilge

Is í príomhaidhm reachtúil an Údarás ná caomhnú agus leathadh na Gaeilge mar theanga phobail agus teaghlaigh. Tá cothabháil agus forbairt na teanga mar chuid lárnach de ghníomhaíochtaí na heagraíochta agus chuige sin cuitear scéimeanna agus tionscnamh áirithe i bhfeidhm chun tabhairt faoi na dúshlán teanga.

Acht na Gaeltachta, 2012 agus an Straitéis 20 Blíain don Ghaeilge 2010-2030

Le linn 2013 cuireadh dlús le hobair phleanála le feidhm a thabhairt d'Acht na Gaeltachta, 2012. Aontaíodh go mbeadh an Ghaeltacht roinnte i 26 Limistéar Pleanála Teanga Ghaeltachta agus rinneadh sainiú iomlán de réir toghrann ar na limistéir sin. Forbraíodh agus aontaíodh próiseas le heagraíochtaí a roghnú le dul i mbun pleannana teanga a ullmhú sna Limistéir Pleanála Teanga. Is é an cuspóir a bheidh ag na pleannana teanga ná cur le húsáid na Gaeilge sna limistéir lena mbaineann siad i réimsí an phobail agus an teaghlaigh, i réimsí oideachais, sóisialta, gnó agus poibl.

Le linn 2013 leanadh le hobair na ngrúpaí oibre atá bunaithe le bunús riarrachán agus treoir fheidhmiúil a leagan síos d'fheidhmiú na Straitéise agus don Acht. Rinneadh seisiúin eolais a reáchtáil ar bhonn réigiúnach

le heolas cothrom le dáta a thabhairt do na heagraíochtaí pobail sa Ghaeltacht faoin bpróiseas pleánala teanga.

I mí na Nollag 2013 rinne an tAire Stáit sa Roinn Ealaón, Oidhreachta agus Gaeltachta, Donnchadh Mac Phionnlaoich, T.D., na céad fhógraí i dtaca le trí Limistéar Pleanála Teanga Ghaeltachta. Cuireadh túis leis an phróiseas agus tá an tÚdarás freagrach as eagraíochtaí a roghnú chun pleannana teanga a ullmhú agus a fheidhmiú sna limistéir éagsúla.

Ionaid Seirbhísí Teanga

Le linn 2013 rinne thart ar 450 duine freastal ar ranganna Gaeilge i 34 ionad atá ag seachadadh cúrsaí Gaeilge ar fud na Gaeltachta.

Scéim Ghaeilge do Chomhlachtaí Gaeltachta

Déantar an Ghaeilge a spreagadh i gcliantchomhlachtaí an Údarás tríd an scéim seo ionas go mbeadh Gaeilge níos infheicthe go poiblí agus in úsáid i gcúrsaí gnó. Rinneadh pleannana teanga a aontú nó a athbhreithniú i gcás 55 cliantchomhlacht le linn na bliana.

Irish Language Activities

The primary statutory objective of Údarás na Gaeltachta is the preservation and extension of the Irish language as a community and family language. All of the organisation's activities have at their core a language maintenance and development objective and to that end specific schemes and initiatives are implemented to address the challenges in relation to language maintenance.

The Gaeltacht Act 2012 and the 20-Year Strategy for the Irish Language 2010-2030

During 2013, initial measures to give statutory effect to the Gaeltacht Act 2012 were developed. It was agreed that the Gaeltacht would consist of 26 Language Planning Areas, and these areas were defined based on electoral divisions. A process was developed and approved, to select suitable lead organisations to begin the language planning process in the Language Planning Areas. The aim of the language plans is to strengthen the use of the Irish language in community and family settings, as well as in education, social, business and public areas.

During 2013, the working groups, set up to establish an administrative base and operational guidelines for the implementation of the Strategy and the Act, continued their development work. Information sessions were organised in various regions to update community

organisations in the Gaeltacht on the language planning process.

In December 2013 the Minister of State at the Department of Arts, Heritage and the Gaeltacht, Dinny McGinley, T.D., announced the first notices in respect of three Gaeltacht Language Planning Areas. The language planning process began and an tÚdarás is responsible for selecting organisations to prepare language plans and operate in the various areas.

Language Services Centres

Over 450 people attended Irish language courses in 34 language services centres throughout the Gaeltacht areas in 2013.

Irish Language Initiative for Businesses

An tÚdarás agreed or reviewed language plans with 55 of its client companies during the year. This support scheme has been devised specifically to promote the Irish language in Údarás client companies in the Gaeltacht with special emphasis on the visibility and the use of Irish language in business context.

Luathoideachas

Is struchtúr neamhspleách é Comhar Naónraí na Gaeltachta Teo a chuireann seirbhís bhainistíochta agus riarrachán ar fáil do naónraí agus seirbhísí eile cúram leanaí sa Ghaeltacht. Le linn 2013 bhí 72 seisiún naónra á riarradh sa Ghaeltacht agus breis agus 876 páiste ag freastal ar na seirbhísí sin. Lena chois sin, d'fhreastail thart ar 260 páiste ar sheirbhísí naíolainne, seirbhísí iarscoile agus seisiún do thuismitheoirí sna ceantair Ghaeltachta éagsúla. Tá 7 fostaithe go lánimseartha agus 147 go páirtaimseartha ag an eagraíocht. Cheadaigh Údarás na Gaeltachta maoiniú de €580,000 do Chomhar Naónraí na Gaeltachta Teo in 2013.

An Óige

Reáchtálann Óige na Gaeltachta Teo clár leathan seirbhís óige sa Ghaeltacht le tacaíocht ó Údarás na Gaeltachta. Bhí 46 club óige ag feidhmiú ar fud na Gaeltachta agus breis agus 1,600 ógánach cláraithe le hÓige na Gaeltachta Teo in 2013. Mar aon leis sin, bhí cheithre ionad buail isteach ag feidhmiú i rith 2013, i gCill Charthaigh, sa Rinn, i gCarna agus sa Cheathrú Rua. Tá ceathrar fostaithe ag Óige na Gaeltachta Teo agus tá oifigí acu i nGaeltacht na Gaillimhe, i dTír Chonaill agus i Múscraí. Cheadaigh Údarás na Gaeltachta maoiniú de €250,000 d'Óige na Gaeltachta in 2013.



Early Childhood Education

Comhar Naónraí na Gaeltachta Teo is the company structure funded by Údarás na Gaeltachta to administer and manage naónraí (preschool groups) throughout the Gaeltacht. There were 72 naónraí sessions operating throughout the Gaeltacht during 2013, catering for some 876 children. In addition, the company catered for approximately 260 children in other services such as crèches, after-school care and parent groups, all of which operate through the medium of Irish in various Gaeltacht areas. Comhar Naónraí na Gaeltachta Teo employs seven fulltime and 147 part-time staff. Údarás na Gaeltachta approved €580,000 in funding to Comhar Naónraí na Gaeltachta Teo in 2013.

Youth

Údarás na Gaeltachta provides funding to the youth organisation Óige na Gaeltachta Teo to assist it organise youth activities in the various Gaeltacht areas. There were 46 youth clubs in operation throughout the Gaeltacht in 2013 with almost 1,600 members registered. In addition, there were four drop in centres in operation during 2013, in Cill Charthaigh, An Rinn, Carna and An Cheathrú Rua. Óige na Gaeltachta Teo employs four people directly and has regional offices in the Galway, Donegal and Múscraí Gaeltacht areas. Údarás na Gaeltachta approved €250,000 in funding to the organisation during 2013.

Eagraíocht agus Seirbhísí

Organisation and Services

Rialachas Corparáideach

Is comhlacht corpraithe é Údarás na Gaeltachta arna bhunú ag an Acht um Údarás na Gaeltachta, 1979, agus feidhmíonn sé faoi shainchúram na Roinne Ealaón, Oidhreachta agus Gaeltachta de réir fhorálacha na nAchtanna um Údarás na Gaeltachta, 1979 go 2010, arna leasú ag Acht na Gaeltachta 2012. Chomh maith lena chuid reacthaíochta rialaithe féin, tá dualgas ar an Údarás freisin cloí le raon de cheanglais reachtúla agus riarracháin eile de chuid an Stáit agus an Aontais Eorpáigh.

Foireann

Ag deireadh 2013 bhí 82 duine fostaithe ag an Údarás. Ceadaíodh don Údarás post dlíodóra agus Bainisteoir Réigiúnach don Tuaiscirt a lónadh.

Comhionannas

Tá Údarás na Gaeltachta tiomanta go hiomlán do pholasáí comhionannais deise, agus tá gach post san eagraíocht oscailte d'fhir agus do mhná. Leanadh le hoiliúint a chur ar fáil don fhoireann i réimsí sábháilteachta agus sláinte i rith 2013 chun féachaint chuige go bhfuil an tÚdarás ag comhlíonadh na bhforálacha reachtúla.

Leanadh le forbairt agus oliúint foirne in 2013. Corporate Governance

Údarás na Gaeltachta is a corporate body established by the Údarás na Gaeltachta Act, 1979, and it operates under the aegis of the Department of Arts, Heritage and the Gaeltacht in accordance with the provisions of the Údarás na Gaeltachta Acts, 1979 to 2010, as amended by the Gaeltacht Act 2012. In addition to its own governing legislation, the agency is also required to comply with a range of other State and EU statutory and administrative requirements.

Staff

At the end of 2013 there were 82 persons employed in the organisation. An tÚdarás received sanctions to fill the positions of Solicitor and Regional Manager for Donegal during the year.

Equality

Údarás na Gaeltachta is committed to a policy of equal opportunity and has developed an equality programme over the years. An tÚdarás continues to operate a number of schemes which provide staff with options in relation to meeting their career and personal needs, such as job sharing, career breaks and reduced working hours. During 2013, 21 staff availed of these schemes.

Within the constraints applying to the recruitment of staff in the Public Service in general, efforts are made to

make suitable job opportunities available to people with disabilities.

The Safety, Health and Welfare at Work Act, 2005

In accordance with the Safety, Health and Welfare at Work Act, 2005, Údarás na Gaeltachta has a written safety statement and continues to implement appropriate measures to protect the safety and health of all employees and visitors at its places of business. An tÚdarás continuously reviews all safety statements to ensure compliance with the provisions of the Safety, Health and Welfare at Work Act, 2005.

During 2013 staff training in various areas of health and safety continued in order to ensure the organisation is fully compliant with legislation.

Staff Training and Development

The staff training and development programme continued in 2013. Members of staff attended a wide range of courses during the year which included day courses, diploma, degree and masters courses in business, management, law, renewable energy, language planning, Irish language, finance and new technology.

Client Care Programme

In accordance with good practice in the Public Service, Údarás na Gaeltachta has adopted a Code of Practice for Quality Client Care. The Client Charter is displayed and available in Údarás offices and on its website www.udaras.ie. The Code of Practice includes procedures for handling disputes and a system for dealing with formal complaints regarding the quality of An tÚdarás' service delivery. Normal procedures are followed for investigating and responding to representations and complaints and to correct any issues as they arise. An tÚdarás continues to place emphasis on improving services to its clients, and to that end procedures are amended and documented as appropriate, to ensure consistent delivery of service.

Under the Public Service Agreements (Croke Park Agreement and Haddington Road Agreement), An tÚdarás has developed an action plan to maintain a high level of public service in an environment where resources and staff numbers are being significantly reduced. This action plan and progress reports are available to download from its website.

In accordance with the Ombudsman (Amendment) Act 2012, provision was made for An tÚdarás to come under the independent oversight of the Ombudsman's Office on 1 May 2013. Information in this regard is provided on the Údarás website www.udaras.ie and in other communication material. Údarás procedures were adjusted and are in line with this new arrangement.

In accordance with the Ethics in Public Office Acts, 1995 and 2001, members of the Board of Údarás na Gaeltachta and staff holding designated positions completed statements of interests as appropriate. Since 2009 the provisions of these Acts apply to the directors and certain managers in the Údarás subsidiaries, who also completed statements in 2013 as appropriate.

Freedom of Information Acts, 1997 and 2003

Údarás na Gaeltachta was brought under the provisions of the Freedom of Information Act on 21 January 2001. During 2013, An tÚdarás received nine requests for records. There were no requests for internal review.

European Communities (Access to Information on the Environment) Regulations 2007 to 2011

With a view to giving effect to Directive 2003/4/EC of the European Parliament and Council on public access to environmental information, the Minister for the Environment, Heritage and Local Government introduced Regulations in Ireland with effect from 1st May 2007.

The Regulations, entitled the European Communities (Access to Information on the Environment) Regulations, S.I. 133 of 2007, and amended by the European Communities (Access to Information on the Environment) Regulations 2011, S.I. 662 of 2011, provide that, subject to certain exceptions, information relating to the

As an organisation dealing with industrial and employment promotion and with community, language and cultural development, Údarás na Gaeltachta has property portfolios in each of the Gaeltacht counties, including land, buildings, industrial estates and business parks. Among the type of information it holds is information on business premises, estates and business parks, including properties let to tenants, environmental information on certain projects supported by An tÚdarás, environmental impact studies for planning purposes, and health and safety files. The Freedom of Information Acts are not affected and they continue to operate in parallel with these Regulations.

Code of Practice for the Governance of State Bodies

Údarás na Gaeltachta has put in place procedures to ensure that it fully complies with the Code of Practice for the Governance of State Bodies. The Cathaoirleach reports accordingly each year in a report to the Minister.

Employment and Payments

Údarás na Gaeltachta publishes an appendix to its Annual Report, comprising tables with employment detailed by county, and payments made by An tÚdarás to individual businesses. This appendix is placed on the Údarás website www.udaras.ie and is available on request.

Prompt Payment of Accounts Act, 1997

Údarás na Gaeltachta comes under the remit of the Prompt Payment of Accounts Act, 1997, which came into effect on 2nd January 1998, the European Communities (Late Payment in Commercial Transactions) Regulations 2002, which came into effect on 7th August 2002, and the European Communities (Late Payment in Commercial Transactions) Regulations 2012, which came into effect on 16 March 2013. It is the policy of Údarás na Gaeltachta to ensure that all invoices are paid promptly, subject to sufficient funds being available.

Specific provisions are in place to enable all invoices to be tracked and to ensure that payments are made by their due date. Invoices are logged daily and weekly payment runs are carried out to ensure prompt payment. These controls are designed to provide reasonable, though not absolute assurance against non-compliance with the Act and Regulations.

From 1 July 2011, in accordance with a Government Decision, non-commercial State agencies, including Údarás na Gaeltachta, are obliged to pay suppliers within 15 days of receipt of a valid invoice. Quarterly reports are published on the Údarás website www.udaras.ie. The following is a summary of that information for the year to 31 December 2013:

In iomlán, úsáideadh 58.22% den fhuinneamh i gcomhair teasa, aer choiriú agus uisce te. D'úsáid soilsú agus trealamh oifige 39.28% agus cócaireacht 2.5% den fhuinneamh.

In 2013 d'úsáid Údarás na Gaeltachta 946 ,830 kWh d'fhuinneamh, rud a léirigh méadú de 8% ar an mbliain roimhe sin, agus bhí sin amhlaidh de thoradh méadú ar uaireanta oibre ó thús mí lúil 2013. Bhí na hoifigí in úsáid 45 uair a chloig sa bheiris sa tréimhse sé mhí sin, agus bhí 90 uair breise d'uaireanta téamh de bharr na huaireanta oibre níos faide.

Official Languages Act 2003

Údarás na Gaeltachta comes under the remit of the Official Languages Act 2003 which was signed into law on 14th July 2003. An tÚdarás complies with the provisions of the Act.

Energy and Environment

Overview of energy usage in 2013

Data available on energy consumption for 2013 illustrates that the Head Office of Údarás na Gaeltachta at Na Forbacha consumed 79.98% of total energy used within their staff occupied offices, the offices at Páirc Ghnó Gaoth Dobhair consumed 14.22% while the offices at Daingean Uí Chúis consumed 5.8%. A total of 58.22% of the energy consumed is attributed to space heating, air conditioning and domestic hot water. Lighting and office equipment accounted for 39.28% while catering represented 2.5%.

In 2013 Údarás na Gaeltachta consumed 946,830 kWh of energy, this showed an increase in usage of 8% over the previous year and is attributed mostly to the longer working hours which came into effect in July 2013. The offices were occupied for an additional 45 hours during that six month period and heating duration was increased by an extra 90 hours to take into account the longer working hours.

The total energy consumed consisted of:

- 371,990 kWh of electricity;
- 551,210 kWh for heating which includes 440,820

- Mhéadaigh an glúin d'fhuinneamh teirmeach 250% agus tháinig laghdú 58% ar úsáid ola ón bhliain roimhe.
- Úsáideadh 23,622 kWh ó ghás peitrilim leachtach i gcomhar cocaireacht san Ard Oifig.

Gníomhartha coigilt fuinnimh a glacadh in 2013

I measc na gníomhaíochtaí coigilt fuinnimh a glacadh, athraíodh na téitheoirí leictreacha a bhí ann go téitheoirí uisce te le brú íseal le bunchomhlá teirmeastatacha agus cuireadh braiteoirí teas nua in áit na sean cinn, le cur amuigh fuinnimh a sheachaint.

In oifigí Daingean Uí Chúis cuireadh tanc idirghabhála leis an gcaidéal teasa agus na ciorcaid teasa faoin urlár chun an buaclód a laghdú agus uaireanta luchtú an chórais a choinneáil ag ráta oíche níos ísle.

Gníomhartha atá beartaithe do 2014

Chuir an córas bainistíocha foirgnimh a insealbhaíodh san Ard Oifig eolas ar fáil faoi aon chur amú fuinnimh agus rachfar i ngleic leis na fadhbanna seo in 2014. Sábhálfaidh na gníomhaíochtaí seo timpeall 9000 kWh.

Tá sé i gceist ag Údarás na Gaeltachta an feachtas feasachta fuinnimh a athbhuanú ina chuid oifigí i 2014 chun an méadú in úsáid fuinnimh i 2013 a cheartú.

kWh of thermal energy delivered from biomass,
110,390 kWh from oil.

- The generation of thermal energy from biomass has increased by 250% while the consumption of oil has decreased by 58% over last year's figures.
- 23,622 kWh represents the consumption of gas used for catering at the Head Office.

Energy saving actions undertaken in 2013

In 2013, actions undertaken at the Head Office in Na Forbacha included the replacement of a number of electric water heaters with secondary water heated from the biomass heating circuit; electric heaters from a number of the outer offices were replaced by low pressure hot water radiators fitted with integral thermostatic valves and a number of old heat sensors were replaced thus avoiding energy wastage.

At our offices at Daingean Uí Chúis a buffer tank was incorporated on the heat pump and under-floor heating circuits to help reduce peak loading and confine charge times on the system to the cheaper night rate electricity unit charge.

Actions planned for 2014

The building management system installed at Head Office has allowed for identification of energy wastage and these issues will be addressed in 2014. Savings on energy resulting from these actions will be in the region of 9000 kWh's. An tÚdarás plan to re-establish an energy awareness campaign in all offices in 2014 in order to reverse the trend of energy usage growth from 2013.

Report of the Comptroller and Auditor General for presentation to the Houses of the Oireachtas

I have audited the financial statements of Údarás na Gaeltachta for the year ended 31 December 2013 under the Údarás na Gaeltachta Act, 1979.

The financial statements, which have been prepared under the accounting policies set out therein, comprise the accounting policies, the operating account, the statement of total recognised gains and losses, the balance sheet, the cash flow statement and the related notes. The financial statements have been prepared in the form prescribed under section 18 of the Act, and in accordance with generally accepted accounting practice in Ireland.

Responsibilities of the Members of An tÚdarás

The Members of An tÚdarás are responsible for the preparation of the financial statements, for ensuring that they give a true and fair view of the state of Údarás na Gaeltachta's affairs and of its income and expenditure, and for ensuring the regularity of transactions.

Responsibilities of the Comptroller and Auditor General

My responsibility is to audit the financial statements and report on them in accordance with applicable law.

My audit is conducted by reference to the special considerations which attach to state bodies in relation to their management and operation.

My audit is carried out in accordance with the International Standards on Auditing (UK and Ireland) and in compliance with the Auditing Practices Board's Ethical Standards for Auditors.

Scope of Audit of the Financial Statements

An audit involves obtaining evidence about the amounts and disclosures in the financial statements, sufficient to give reasonable assurance that the financial statements are free from material misstatement, whether caused by fraud or error. This includes an assessment of

- whether the accounting policies are appropriate to Údarás na Gaeltachta's circumstances, and have been consistently applied and adequately disclosed
- the reasonableness of significant accounting estimates made in the preparation of the financial statements, and
- the overall presentation of the financial statements.

I also seek to obtain evidence about the regularity of financial transactions in the course of audit.

In addition, I read all the Údarás' annual report to identify material inconsistencies with the audited financial statements. If I become aware of any apparent material misstatements or inconsistencies I consider the implications for my report.

- The statement on internal financial control does not reflect Údarás na Gaeltachta's compliance with the Code of Practice for the Governance of State Bodies, or
- I find there are other material matters relating to the manner in which public business has been conducted.

I have nothing to report in regard to those matters upon which reporting is by exception.

Statement on Internal Financial Control

On behalf of the Board of Údarás na Gaeltachta, I acknowledge our responsibility for ensuring that an effective system of internal financial control is maintained and operated.

The Board has taken steps to ensure an appropriate control environment is in place by:

- Clearly defining management responsibilities and powers;
- Establishing formal procedures for monitoring the activities and safeguarding the assets of the organisation;
- Developing a culture of accountability across all levels of the organisation.

The Board has established processes to identify and evaluate business risks by:

- Identifying the nature, extent and financial implication of risks facing the body including the extent and categories which it regards as acceptable;
- Assessing the likelihood of identified risks occurring;
- Working closely with Government and various agencies to ensure that there is a clear understanding of Údarás na Gaeltachta's goals and support for the strategies to achieve those goals.

The system of internal financial control is based on a framework of regular management information, administration procedures including segregation of duties, and a system of delegation and accountability. In particular it includes:

- A comprehensive budgeting system with an annual budget which is reviewed and agreed by the Board of Údarás na Gaeltachta;
- Regular reviews by the Board of Údarás na Gaeltachta of periodic and annual financial reports which indicate financial performance against forecasts;
- Setting targets to measure financial and other performance;
- Clearly defined capital investment control guidelines;
- Formal project management disciplines.

Glactar le Caighdeán Tuiriscithe Airgeadais arna moladh ag na comhlachtaí aitheanta cuntasáiochta, de réir mar a thagann siad i bhfeidhm.

(b) Deontais an Oireachtas, Cistí Struchtúrtha an AE agus Aisíocaíochtaí Deontas agus Díbhinní

Comhairítear na nithe seo ar bhonn fáiltais airgid thirim.

(c) Deontais Iníochta

Comhairítear na nithe seo ar bhonn íocaíochtaí airgid thirim.

(d) Scéim Aoisliúntais

Feidhmíonn Údarás na Gaeltachta scéim phinsin le sochar sainithe a mhaoinítear go bliantúil ar bhunús ioc mar a úsáidtear ó airgead atá ar fáil dó, ar a n-áirítear airgead a chuireann an Roinn Ealaón, Oidhreachta agus Gaeltachta ar fáil agus asbhaintí as tuarastal foirne.

Is ionann costas na bpínsean agus na sochair phinsean a shaothraíonn na baill foirne sa tréimhse agus léirítear iad mar ghlanchostas, glan ó ranníocaíochtaí foirne a choinníonn an tÚdarás. Aithnítear suim atá comhionann leis an gcostas pinsin mar ioncam sa mhéid is go bhfuil sé infhaichte ar ais, agus go gcuirtear deontais a fhaightear sa bhliaín, chun costais phinsean a ioc, ina aghaidh.

Léirítear gnóthachain agus cailteanas achtúireacha a thagann as dliteanas scéime sa Ráiteas Gnóthachan agus Cailteanas Aitheanta lomlán agus aithnítear coigeartú comhfheagrach sa tsuim infhaichte ón Roinn Ealaón, Oidhreachta agus Gaeltachta.

Léiríonn dliteanas phinsean luach láithreach na n-íocaíochtaí fáistineacha pinsean atá saothraithe ag an bhfoireann go dáta. Is ionann an maoiniú pinsean iarchurtha agus an bhunsócmhainn chomhfheagrach a gheofar sa todhchaí ón Roinn Ealaón, Oidhreachta agus Gaeltachta.

(e) Sócmhainní Dochta

Úsáidtear formhór shócmhainní na heagraíochta i bhforbairt tionscail. Ní bhreathnaítear orthu mar mhaoin infheistíochta agus áirítear iad sa Chlár Comhardaithe ar bhonn costais líuide dímheas carnach.

Áirítear mar mhaoin agus áiseanna tionsclaíocha talamh, foirgnimh thionsclaíocha críochnaithe, áiseanna tionsclaíocha, forbairt suímh agus foirgnimh oifige.

Áirítear talamh ar bhonn costais.

Accounting Policies

Údarás na Gaeltachta Act, 1979

Údarás na Gaeltachta was established on 1 January 1980 under the provisions of the Údarás na Gaeltachta Act, 1979.

The significant accounting policies adopted by An tÚdarás are as follows:

(a) Basis of Accounting

These financial statements are prepared in accordance with section 18 of the Údarás na Gaeltachta Act, 1979 under the accruals method of accounting, except as indicated below, and in accordance with generally accepted accounting principles under the historical cost convention. Financial Reporting Standards as recommended by the recognised accountancy bodies are adopted, as they become operative.

(b) Oireachtas Grants, EU Structural Funds and Grant Refunds and Dividends

These items are accounted for on a cash receipts basis.

(c) Grants Payable

Grants are accounted for on a cash payments basis.

(d) Superannuation Scheme

Údarás na Gaeltachta operates a defined benefit pension scheme which is funded annually on a pay as you go basis from monies available to it, including monies provided by the Department of Arts, Heritage and the Gaeltacht and from contributions deducted from staff salaries.

Pension costs reflect pension benefits earned by employees in the period and are shown net of staff pension contributions which are retained by An tÚdarás. An amount corresponding to the pension charge is recognised as income to the extent that it is recoverable, and offset by grants received in the year to discharge pension payments.

Actuarial gains or losses arising on scheme liabilities are reflected in the Statement of Total Recognised Gains and Losses and a corresponding adjustment is recognised in the amount recoverable from the Department of Arts, Heritage and the Gaeltacht.

Pension liabilities represent the present value of future pension payments earned by staff to date. Deferred pension funding represents the corresponding asset which will be recovered in future periods from the Department of Arts, Heritage and the Gaeltacht.

(e) Fixed Assets

The major portion of the organisation's assets are used to aid industrial development. They are not seen as investment assets and they are stated in the balance sheet at cost less accumulated depreciation.

Property and other facilities comprise land, completed industrial properties, industrial facilities, site development and office buildings.

Land is stated at cost.

(nó de réir ráta comhionann leis an ioncam faoin léas má tá sé níos airde).

(f) Infheistíochtaí

Luacháil: Léirítear infheistíochtaí i scaireanna ar bhonn costais móide nó lúide soláthar don difríocht idir costais agus luacháil infheistíochta bunaithe ar ghlanluach sócmhainní.

Aitheantas gnóthachan agus caillteanas ar infheistíochtaí:

Aithnítear gnóthachan agus caillteanas a fhaightear de bharr diúscartha infheistíochtaí san gcontas loncam agus Caiteachas. Aithnítear gnóthachan agus caillteanas neamhréadaithe de bharr athraithe i luacháil infheistíochtaí san Ráiteas Gnóthachan agus Caillteanas Aitheanta lomlán.

Tá clár na n-infheistíochtaí leagtha amach i Nóta 14 agus Sceideal 1 de na ráitis airgeadais seo.

Ní léiríonn na ráitis airgeadais aon chomhdhlúthú ar thortháí fochuideachtaí ná comhchuideachtaí. Sé tuairim an Údarás go gcuirfeadh comhdhlúthú dá leithéid na cuntais as a riocth, go háirithe nuair a chuirtear san áireamh an éagsúlacht a bhaineann le gnóthaí na gcuideachtaí ina bhfuil infheistíochtaí chomh maith le dualgas ginearálta an Údarás fein.

(g) Léasanna

Árítear na cíosanna ó léasanna oibríocha sna ráitis airgeadais mar a mbíonn siad iníocha.

Comhairítear an glan-ioncam ó shócmhainní atá ar léas ó institiúidí airgeadais, agus a léasaítear ar aghaidh le cliant-chuideachtaí, faoi loncam Eile sa Chuntas Oibríoch ar bhunús fabhraithe.

(h) Caipiteal

San áireamh sa chuntas caipítil tá ioncam a chuirtear i leith cistithe caipítil agus gach gnóthachan, caillteanas agus athluacháil ar idirbhearta sócmhainní agus infheistíochtaí (Nóta 17).

(i) Scéimeanna Fostaíochta agus Sóisialta

Láimhseáлann an tÚdarás scéimeanna éagsúla ar son na Roinne Coimirce Sóisialaí. Aithnítear caiteachas ar na scéimeanna seo de réir mar a tharlaíonn sé, agus fabhraítear an t-ioncam gaolmhar sna ráitis airgeadais (Nóta 4).

All other assets are stated at cost less accumulated depreciation calculated in equal annual instalments over their estimated useful economic lives.

Cost of properties includes an appropriate portion of the site and other infrastructural development costs necessary for the construction of the properties, together with an appropriate portion of the Property and Engineering Division overheads as set out in Note 11.

The depreciation rates applied are as follows:

Property	4% p.a.
Industrial Facilities	3% p.a.
Machinery, Office Equipment and Furniture	10% to 25% p.a.
Motor Vehicles	20% p.a.
Leased Machinery and Equipment	20% p.a.

(or at a rate equal to the income under the lease if this is higher).

(f) Investments

Valuation: Investments in shares are shown at the cost plus or minus a provision for the difference between cost and investment valuation which is calculated on a net asset basis.

Recognition of gains and losses on investments:

Gains and losses realised as a result of disposal of investments are recognised in the Income and Expenditure accounts. Unrealised gains and losses resulting from changes in the valuation of investments are recognised in the Statement of Total Recognised Gains and Losses.

Details of the investments are set out in Note 14 and Schedule 1 of these financial statements.

The financial statements do not reflect a consolidation of the results of subsidiary or associate companies. An tÚdarás is of the opinion that such a consolidation would be misleading having regard to the diverse nature of the business of the companies and to the general duty of the organisation.

(g) Leases

Rentals under operating leases are dealt with in the financial statements as they fall due.

The net income from assets which are leased from financial institutions and on-leased to client companies is accounted for in Other Income in the Operating Account on the accruals basis.

(h) Capital

(e) General Description of the Scheme

The Pension Scheme is a defined benefit final salary pension arrangement with benefits and contributions defined by reference to current "model" public sector scheme regulations. The scheme provides a pension (one eightieth per year of service), a gratuity or lump sum (three eightieths per year of service) and spouse's and children's pensions. Normal Retirement Age is a member's 65th birthday, and pre 2004 members have an entitlement to retire without actuarial reduction from the age of 60. Pensions in payment (and deferment) normally increase in line with general public sector salary inflation.

The valuation used for FRS 17 disclosures has been based on a full actuarial valuation at 31 December 2012. This has been updated up to 31 December 2013 by an independent qualified actuary to take account of the requirements of FRS 17 in order to assess the scheme liabilities at 31 December 2013.
