Tá ceantair fhairsinge Ghaeltachta i gcontaetha Dhún na nGall, Mhaigh Eo, na Gaillimhe agus Chiarráí agus pobail níos lú i gcontaetha Phort Láirge, Chorcaí agus na Mí. Tá na ceantair Ghaeltachta sainithe ag orduthe Rialtais agus tá sé atitheanta ag rialtas i ndiaidh a chéile go bhfuil gá le bearta, struchtúir agus maoiniú ar leith chun cothabháil na bpobal seo a chinntiú.

Soláthraíonn an Ghaeltacht deis agus dúshlán chun leanúnachas na Gaeilge mar theanga phobail a choinneáil beo go nádúrtha. Soláthraíonn sí timpeallacht do dhaoine ar mian leo an Ghaeilge a bheith ar a dtóil acu agus tá sí mar chuid dílis agus inspioráideach den sprioc náisiúnta socháí dhátheangach a bhaint amach.

De réir Daonáirimh 2011, is é daonra iomlán na gceantar Gaeltachta ná thart ar 100,000.



The Gaeltacht

The Gaeltacht covers extensive parts of counties Donegal, Mayo, Galway and Kerry and small parts of counties Waterford, Cork and Meath. Although all of the Gaeltacht population speak English, these are the only parts of Ireland where Irish is still spoken as a community language. The Gaeltacht areas are defined by Government orders and every successive government has recognised the need for specific measures, structures and funding to ensure the maintenance of these communities.


The Gaeltacht presents an opportunity and a challenge to maintain naturally the continuity of Irish as a community language. It provides the ideal environment for people who wish to become proficient in Irish and forms an integral and inspirational element of the national objective of achieving a bilingual society in Ireland.

The total population of the Gaeltacht areas in the 2011 Census was approximately 100,000.

Údarás na Gaeltachta

Is é Údarás na Gaeltachta, a bunaíodh i 1980, an t-údarás forbartha réigiúnach atá maoinithe ag an Rialtas chun forbairt eacnamaíochta, shóisialta agus chultúrtha na Gaeltachta a chur chun cinn. Tá sé mar mhór-aidhm aige an Ghaeilge a chothú mar theanga phobail an réigiúin. Chun na haidhmeanna sin a chur chun cinn, tacáonn an tÚdarás le scéimeanna táirgiúla fostaochta trí forbairt a dhéanamh ar acmhainní nádúrtha áitiúla, ar scileanna agus ar chumais fhiontraíochta, trí infheistíocht shoghluiste a mhealladh chun na Gaeltachta agus trí thacaíocht a thabhairt do thionscnaimh fhorbartha pobail. Cuidíonn sé freisin le réimse leathan de thionscnaimh theanga, chultúrtha agus oideachais atá dírithe ar an nGaeilge a neartú mar phríomh-mheán cumarsáide i ngach earnáil de shaol an phobail.

Tá fiche comhalta ar bhord an Údaráis, seacht nduine dhéag acu tofa go daonlathach ag toghthóirí na Gaeltachta i dtoghcháin a réachtáiltear

tráthanna idir 4 bliana agus 7 mbliana agus 6 mhí óna chéile, agus an triúr eile, an cathaoirleach san áireamh, ceaptha ag an Aire. Ag deireadh na bliana bhí foireann de 95 duine agus gréasán d'oifigí réigiúnacha sna Gaeltachta éagsúla aige chun dualgais reachtúla an Údarás a chur i bhfeidhm. D'fhógair an Rialtas in 2011 go bhfoilseofá reachtaíocht nua ina ndéanfai foráil chun an bord seo a laghdú agus chun deireadh a chur leis an riachtanas do thoghcháin díreacha.

Ag deireadh na bliana bhí 6,970 duine fostaithe i gcliantchomhlachtaí a fuair tacaíocht airgeadais ó Údarás na Gaeltachta i réimsí ar nós déantúsaíochta, uisceachaíothrú, innealtóireacht, gníomhaíochtaí closamhairc, seirbhísí trádáilte idirnáisiúnta, na heolaíochtaí beatha, turasóireacht, seirbhísí teanga, an geilleagar sóisialta agus acmhainní nádúrtha.



Údarás na Gaeltachta

Established in 1980, Údarás na Gaeltachta is the regional development authority funded by the Government to promote the economic, social and cultural development of the Gaeltacht with the overall objective of maintaining Irish as the main communal language of the region. In furtherance of these aims, An tÚdarás promotes productive schemes of employment through the development of local natural resources, skills and entrepreneurial abilities and the attraction of mobile investment to the Gaeltacht. It also promotes and supports community development initiatives and a wide range of language, cultural and educational schemes aimed at strengthening the place of Irish as the principal means of communication among all sections and sectors of the community.

An tÚdarás has a 20 member board, 17 of whom are democratically elected by the Gaeltacht electorate at elections held at intervals not less than 4

years and not more than 7 years and 6 months, the other three, including the chairperson, being appointed by the Minister. At year end the organisation had a staff of 95 people and a network of regional offices throughout the Gaeltacht to implement its statutory brief. The Government announced in 2011 that new legislation would be published which would provide for a reduction in the size of this board and for an end to the requirement to hold direct elections.

At year end, there were 6,970 people employed in Údarás supported sectors such as manufacturing, aquaculture, engineering, audio-visual activities, internationally traded services, life sciences, tourism, language services, the social economy and natural resources.

Coistí Réigiúnacha

Faoi reachtaíocht an Údarás leagadh síos go ndéanfadh comhaltaí ionadaíocht ar a gceantair féin ar thrí Choiste Réigiúnacha do Dhún na nGall, do Chonnacht/Laighin agus don Mhumhain. Is féidir leis na Coistí sin deontais charnacha suas go dtí €350,000 a cheadú do thionscadail. Bhí idir trí chruinníú agus sé chruinníú ag gach Coiste Réigiúnach le linn na bliana.

Regional Committees

Under Údarás legislation members represent their own areas on three Regional Committees for Donegal, Connacht/Leinster and Munster. The Committees can approve grant-aid to projects up to a cumulative level of €350,000. Each Regional Committee held three to six meetings during the year.

An Coiste Meastóireachta

Is coiste reachtúil é seo a dhéanann meastóireacht ar thionscadail mhóra agus a chuireann moltaí chuig an mBord. Ar an gcoiste sin bíonn an Cathaoirleach, triúr comhaltaí tofa boird agus an Príomhfeidhmeannach mar aon le hionadaithe ón Roinn Ealaíon, Oidhreachta agus Gaeltachta, An Gníomhaireachta Forbartha Tionscail (Éire) agus Fiontraíocht Éireann. Bhí dhá chruinníú ag an gcoiste seo sa bhliain 2011.

Evaluation Committee

This is a statutory committee which evaluates large-scale projects and makes recommendations to the Board. Membership comprises the Chairman, three elected board members and the Chief Executive as well as representatives from the Department of Arts, Heritage and the Gaeltacht, IDA (Ireland) and Enterprise Ireland. Two meetings were held by this committee in 2011.

An Coiste Iníúchta

De réir an Chóid Chleachtais um Rialachas Comhlacthaí Stáit, tá Coiste Iníúchta ag Údarás na Gaeltachta. Scrúdaíonn an coiste seo ráitis airgeadais, gnóthaí rialaithe chorparáidigh agus bainistíochta riosca, tuairisci ón bhfeidhm Iníúchóireachta Inmhéánaí agus ón Ard-Reacaire Cuntas agus Ciste, agus obair eile a dhéantar i dtaca leis an eagraíocht agus lena chuid fochuideachtaí. Féach thíos liosta de bhaill an choiste.

Audit Committee

In accordance with the Code of Practice for the Governance of State Bodies, Údarás na Gaeltachta has an Audit Committee. This committee examines financial statements, corporate governance and risk management matters, reports from the Internal Audit function and from the Comptroller and Auditor General, and other work carried out in relation to the organisation and its subsidiary companies. Le blianta anuas bhí comhaltaí boird páirteach i bhfochoistí éagsúla a dhírigh ar ghnóthaí a bhain le cultúr, teanga, oideachas agus oiliúint, bunstruchtúr, forbairt pobail, comharchumainn, oileáin agus ceantair thearcfhorbartha.

I rith na bliana 2011, áfach, dhírigh an tÚdarás féin agus a chuid Coistí Réigiúnacha ar ábhair dá leithéidí, go háirithe i dtaca le feidhmeanna fiontraíochta agus fostáiochta an Údarás, le Straitéis 20 Blíain an Rialtais don Ghaeilge 2010-2030 agus reachtaíocht Gaeltachta nua a bhí beartaithe. Cuireadh coistí *ad hoc* le chéile chun ceisteanna ar leith a chíoradh i gcásanna áirithe.

Subcommittees

For some years board members have participated in subcommittees which focused specifically on issues relating to culture, language, education and training, infrastructure, community development, cooperatives, islands and underdeveloped areas. However, during 2011 such matters were dealt with through An tÚdarás and its Regional Committees, in particular in respect of the Údarás enterprise and employment functions, the Government's 20-Year Strategy for the Irish Language 2010-2030 and new Gaeltacht legislation that was being proposed. *Ad hoc* committees were established in some cases to examine particular matters.




Employment by sector


Grants approved in 2011 by sector

Ráiteas an Chathaoirligh Chairman's Statement



Ráiteas an Chathaoirligh

Is mór an t-ábhar misnígh é gur éirigh le cliantchomhlachtaí Údarás na Gaeltachta an fhostaíocht a choinneáil nach mór seasmhach le linn 2011. Bhí 6,970 post lánaimseartha i gcliantchomhlachtaí an Údarás ag deireadh na bliana. Tháinig laghdú ar ráta na gcaillteanas post le linn na bliana. Tá an lín post a cailleadh le bliain anuas ag leibhéal i bhfad níos ísle ná mar bhí le roinnt blianta anuas, le laghdú 40% in 2011 i gcomparáid le 2009. Cé go raibh glanchaillteanas de 104 post i gceist, is léiriú é an laghdú i gcaillteanas post ar an tionchar dearfach atá ag straitéis an Údarás, a dhírigh le trí bliana anuas ar thacú le gnóthaí a bhí ann cheana a leibhéal fostaíochta a choinneáil slán. Tharla na laghduithe post don chuid is mó de bharr comhlachtaí a bheith ag sileadh líon beag fairne chun gearradh siar ar chostais. Is iad na comhlachtaí a bhí ag trádáil sa mhargadh baile is mó a bhí buailte.

Luach eacnamaíoch chomhlachtaí Gaeltachta

Taispeánann taighde a rinne Forfás in 2011 go raibh diolachán iomlán de €750 milliún ag cliantchomhlachtaí an Údarás an bhliain roimhe sin, agus gur bhain €399 milliún de le heaspórtáil, méadú 13% ar an bhliain roimhe sin.

Leibhéal suntasach post nua cruthaithe agus tograí nua ceadaithe

Cruthaíodh 734 post nua i bhfiontair Ghaeltachta in 2011, beagnach ar an líon céanna leis an bhliain roimhe sin. Tháinig ardú ar an leibhéal fostaíochta i gcomhlachtaí a bhí ag plé le heaspórtáil, gnóthaí sna hearnálacha feistí Leighis, closamhairc agus na meáin dhigiteacha, seirbhísí airgeadais, agus saindéantusaíochta anuraidh. D'fhogair roinnt comhlachtaí go raibh pleannána forbartha acu agus go raibh siad chun infheistíocht bhereise a dhéanamh i dtaighde agus forbairt chomh maith i rith na bliana.

In ainneoin na haeráide eacnamaíochta dúshlánaí agus an maoiniú laghdaithe a bhí ar fáil ón Státhiste, cheadaigh Údarás na Gaeltachta tograí ina mbeidh infheistíocht iomlán mheasta de €21 milliún ag baint leo in 2011. Táthar ag síúl go gcruthófar 400 post nua i gcomhlachtaí Gaeltachta nuair a bheidh na tograí sin faoi lán seoil.

Tábhachtach go leanfar le ceadú poist nua ach maoiniú bheith ar fáil

Caillear poist go bliantúil mar ghnáth-chuid den saolré gnó de réir mar a athraíonn treochtaí na n-earnálacha agus mar a dhéanann fiontair athstruchtúrú ar a ngnó chun feabhas a chur ar a gcumas iomaíochta. Tá sé thar a bheith tábhachtach mar sin go mbeadh sé d'acmhainn ag an Údarás tacú le poist nua leis an leibhéal fostaíochta sa Ghaeltacht a choinneáil slán agus bunús fáis don todhchaí a chinntíú. Lean an tÚdarás air ag comhoibriú go dlúth le heagraíochtaí forbartha eile lena chinntíú go bhfaighidh an Ghaeltacht agus lucht gnó na Gaeltachta an tairbhe is fearr as aon chláir forbartha fiontraíochta náisiúnta.

Chairman's Statement

It is most encouraging that employment levels within Údarás client companies remained stable during 2011. Total employment in Údarás client companies stood at 6,970 at 2011 year end. The rate of job losses declined during the year. The number of jobs lost over the last year is at a significantly lower level than that experienced over the last number of years, with a 40% decrease in the number of jobs lost in 2011 compared to 2009. While there was a net loss of 104 jobs, the decline in the number of jobs lost is evidence that Údarás' strategy, which over the past three years focused on supporting existing businesses, is having a positive effect on job maintenance. The job reductions occurred mostly due to companies shedding a small number of staff in order to rationalise and reduce costs. Companies trading in the domestic market were those mainly affected.

Economic impact of Gaeltacht companies

Research undertaken in 2011 by Forfás shows that total sales in Údarás client companies was in the region of €750 million in the previous year, of which €399 million of this was in export sales, an increase of 13% on the previous year.

A significant number of new jobs created and new projects approved

At total of 734 new jobs were created in Gaeltacht enterprises in 2011, a similar level to that of the previous year. Companies involved in exporting, including businesses in the medical devices, audio-visual and digital media, financial services, and specialist manufacturing sectors, increased their employment numbers during the year, with some companies announcing expansion plans and further investment in R&D.

Notwithstanding the challenging economic business environment and reduced funding available from the exchequer, Údarás na Gaeltachta approved projects during the year which will involve an overall projected investment of €21million in Gaeltacht companies and are expected to create some 400 jobs when up and running.

Continuation of jobs approval vital - subject to available funding

Jobs are lost annually as a normal part of the business lifecycle as sectoral trends change, enterprises restructure and companies streamline to improve their competitiveness and it is therefore critical that Údarás has the resources to support new jobs to ensure employment levels are maintained and provide a basis for growth into the future. An tÚdarás continued to work closely with other development agencies to ensure that the Gaeltacht and Gaeltacht businesses derive maximum benefit from national enterprise development programmes.

I rith 2012, díreoidh straitéis fiontraíochta an Údarás ar thacaíocht a sholáthar dá chomhlachtaí reatha, infheistíocht bhireise a lorg ó chliaint nua agus reatha, agus tacú le fointair a bheidh bunaithe ar acmhainní nádúrtha ar nós uisceachaothrú, turasóireacht, foraoiseacht, agus a leithéid. Cuirfear béim ar leith ar an fhostaíochta a cailleadh i gceantair áirithe le roinnt blianta anuas a athchur agus ar an líon fostáiochta sa Ghaeltacht a thabhairt ar ais chuig leibhéal a bhí ann roimhe seo.

Gníomhaíochtaí teanga

Lean an tÚdarás lena chlár tacaíochta do ghníomhaíochtaí pobail agus teangabhunaithe sa Ghaeltacht in 2011. Tá ionadaíocht ag an Údarás ar ghrúpaí oibre atá bunaithe le síniú ar chur i bhfeidhm na Straitéise 20 Blíain don Ghaeilge 2010-2030. Is é aidhm na ngrúpaí oibre ná scrúdú a dhéanamh ar an réimse feidhmeanna a bheadh ag Údarás na Gaeltachta, An Roinn Ealaón, Oidhreachta agus Gaeltachta agus Foras na Gaeilge ag tógáil san áireamh feidhmeanna agus gníomhaíochtaí reatha mar aon leis na bearta sonracha atá luate i réimsí gnímh na Straitéise, agus moltaí a dhéanamh maidir leis na struchtúir, na hoifigí, na hacmhainní agus an líon foirne a theastódh chun na feidhmeanna sin a chur i gcrích. Tá muid ag súil go mór le síniú ar na bearta seo sa bliaín atá amach romhainn i gcomhar leis an dá eagraíocht sin.

During 2012, Údarás will focus its enterprise strategy on supporting its existing client base, seeking further investment from new and current clients, and supporting natural resource-based enterprises such as aquaculture, tourism and forestry. Údarás will concentrate on replacing the employment lost in certain areas over the last number of years and begin to grow overall employment numbers in the Gaeltacht to previous levels.

Language-based initiatives

During 2011, Údarás continued to support community and Irish language-based activities in the Gaeltacht. Údarás na Gaeltachta has an active role on the working groups involved in the implementation of the 20-Year Strategy for the Irish Language 2010-2030. The objective of these working groups is to examine the functions which Údarás na Gaeltachta, the Department of Arts, Heritage and the Gaeltacht and Foras na Gaeilge will have, taking into account their current functions and activities in addition to the specific measures and activities outlined in the Strategy, and to make recommendations regarding the structure, offices, resources and staff numbers required for the implementation of those functions. Over the coming year, we look forward to focusing on these activities in conjunction with both organisations.

Buíochas

Review of 2011



Forbairt Fiontraíochta

Tugann an tÚdarás faoi réimse leathan gníomhaíochtaí fiontraíochta agus forbartha chun a fheidhmeanna i dtaca le cruthú agus caomhnú fostáochta sa Ghaeltacht a bhaint amach. Tá na fointair a fhagheann tacáiocht ag feidhmiú in earnálacha ar nós eolaíochtaí beatha (bithealighis agus cógaisíocht), teicneolaíocht faisnéise agus cumarsáide, déantúsaíocht nideoige (earraí innealtóireachta agus tomhaltais), closamhairc agus na meáin dhigiteacha, turasóireacht, fointair mhara agus theangabhunaithe.

Cruthaíodh 734 post nua in 2011 i gcomhlacthaí a fuair cúnamh ón Údarás. Tháinig laghdú suntasach ar líon na bpost a cailleadh ó 1,102 in 2010 go 838 in 2011. Bhí 6,970 duine fostaithe i gcliantchomhlacthaí de chuid an Údarás ag deireadh na bliana. Taispeánann na figiúirí fostáochta gur éirigh go maith le comhlacthaí atá ag plé le heaspórtáil, rud atá ar aon dul leis an treocht náisiúnta. Is údar misnígh é go ndearna roinnt de na comhlacthaí sin tuilleadh infheistíochta agus forbartha ina ngnótháí i rith na bliana. Tharla tromlach na gcaillteanas de bharr fointair a bheith ag laghdú foirne chun gearradh siar ar chostais, athstruchtúrú agus comhdhlúthú. Is comhlacthaí beaga, go háirithe iad siúd a bhí ag trádáil sa mhargadh baile amháin, agus comhlacthaí bainteach leis an earnáil turasóireachta nó tógála is mó a bhí buaile.

Poist a Ceadáodh

Ceadáodh 398 post nua i rith 2011 i bhfointair nua agus reatha le hinfeistíocht mheasta iomlán de bhreis is €21 milliún i gcomhlacthaí

Gaeltachta. Laghdú é sin ar an 535 post a ceadaíodh an bliain roimhe sin, cé gur méadú beag é ar an 368 post a ceadaíodh in 2009. Is iad an ghéarchéim eacnamaíochta domhanda, laghdú ar líon na dtionscadal nua a tháinig chun tosaigh ag lorg tacaíochta mar gheall ar dheacrachtaí maoinithe nó lagú ina gcúrsaí gnó, agus laghdú ar an leibhéal maoinithe a bhí ar fáil don Údarás óna fhoinsí maoinithe féin agus ón Státhiste, na cíuseanna ba mhó leis an laghdú i líon na bpost a ceadaíodh in 2011.

Tionchar Eacnamaíoch Chlaintchomhlacthaí an Údarás

Léiríonn eolas ón suirbhé eacnamaíoch ABSEI (Annual Business Survey of Economic Impact) is déanaí a rinne Forfás in 2011 do na gníomhaireachtaí forbartha go léir:

- go raibh díolachán iomlán de €750 milliún ag claintchomhlacthaí an Údarás an bliain roimhe, sin méadú 13%. Bhain os cionn 50% den díolachán iomlán le heaspórtáil;
- go ndearna os cionn 40% de chlaintchomhlacthaí an Údarás infheistíochta i dTaighde agus Forbairt, le caiteachas iomlán de €20 milliún.

Rinne an ABSEI suirbhé ar chlaintchomhlacthaí de chuid an Údarás ina bhfuil 75% den fhostaíocht iomlán agus léirigh na tortaí go ndéanann siad ranníocaíocht suntasach chuig eacnamaíochta na hÉireann.

Maoiniú Stáit

Tá infheistíocht Stáit thart ar €9.4 milliún i gceist leis an gcúnamh agus caiteachas a cheadaigh an tÚdarás i rith na bliana 2011 do thionscadail

Enterprise Development

An tÚdarás undertakes a wide range of enterprise and development activities in fulfilment of its functions in relation to the creation and maintenance of employment in the Gaeltacht. Enterprises supported operate in sectors such as life sciences (biomedical and pharmaceutical), information and communications technology, niche manufacturing (engineering and consumer goods), audio-visual and digital media, tourism, marine and language-based enterprises.

A total of 734 new jobs were created in Údarás-assisted companies in 2011. Job losses decreased from 1,102 in 2010 to 838 in 2011. Total full-time employment at year end was 6,970. The employment figures show a strong performance by exporting companies, reflecting the national trend. It is encouraging to see that a number of those companies continued to invest further and expand their operations during the year. The majority of the job losses occurred as a result of enterprises shedding staff numbers in order to cut costs, restructure and consolidate. Smaller companies, especially those trading solely in the domestic market, and companies involved in tourism or the construction related sectors were the most affected.

Job Approvals

A total of 398 new jobs were approved during 2011 in new and existing enterprises involving an overall projected investment of over €21 million

in Gaeltacht companies. This figure is a reduction from the previous year's approval of 535 jobs, but a small increase from the 368 jobs approved in 2009. A number of combined factors led to a lower amount of new jobs being approved and these were the global economic crisis, a reduction in new projects coming forward for assistance owing to funding constraints or a downturn in business, and reduced funding available to An tÚdarás from its own sources and from the exchequer.

Economic Impact of Údarás Client Companies

Results from the most recent ABSEI survey (Annual Business Survey of Economic Impact) carried out and published by FORFÁS in 2011 in respect of all development agencies indicate that:

- total sales in Údarás client companies was in the region of €750 million in the previous year, an increase of 13%. Over 50% of total sales were in exports;
- over 40% of Údarás client companies invested in Research and Development, amounting to €20 million in expenditure.

State Funding

Assistance and expenditure approved by An tÚdarás in 2011 for employment and other development projects, for education and training, and for infrastructure involved an overall State investment of some €9.4 million.

Taighde agus Forbairt

Lean an tÚdarás de bhéim ar leith a chur ar chaiteachas ar ghníomhaíochtaí taighde agus forbartha ina chlaintchomhlachtaí agus é ag cabhrú le gnótháí forbairt a dhéanamh ar a gcumas iomaíochta. In 2011, ceadaíodh €1.5 milliún (€1.2 milliún faoin scéim Taighde, Forbartha agus Nuálaíochta (T&F&N)) i ndeontais dírithe ar thaighde agus forbairt do chlaintchomhlachtaí de chuid an Údarás. Iocadh €1.6 milliún i ndeontais dírithe ar thaighde agus forbairt i rith na bliana. Tá an tÚdarás, i gcomhar le Fiontraíocht Éireann, tiomanta do chomhoibriú le comhlachtaí tríd an scéim Taighde, Forbartha agus Nuálaíochta (T&F&N) a fheidhmiú, chun an bonn taighde agus nuálaíochta san earnáil fiontraíochta a neartú.

Costas in Aghaidh an Phoist

Bhí costas deontais de €8,212 in aghaidh an phoist in 2011 agus bhí meánchostas de €11,259 in aghaidh an phoist i gceist thar na cúig bliana seo caite. Léiríonn an costas in aghaidh an phoist an caiteachas deontais ar chaipiteal, fhostaíocht, taighde agus forbairt agus ar oiliúint a íocatar le claintchomhlachtaí ach ní áirinn sé deontais FIFG (Ionstraim Airgeadais do Threoir lascaireachtaí) ná T&F&N. Ní áirítear caiteachas eile i leith oiliúna ná oideachas mar níl ceangal díreach idir mórchuid an chaiteachais ar na clár oideachais tríú leibhéal agus foghlama fadsaoil atá á maoiniú agus clár chruthaithe fostáiochta na bliana reatha.

Research and Development

An tÚdarás continued to place special emphasis on research and development expenditure as it assisted its client companies to develop their competitive capacities. In total, some €1.5 million (€1.2 million under the R&D&I scheme) was approved in research and development type grants in 2011 for Údarás client companies. Total grants paid out to companies undertaking research and development activities amounted to €1.6 million during the year. An tÚdarás, in co-operation with Enterprise Ireland, is committed to working with companies through the R&D&I scheme, to strengthen the research and innovation base of the enterprise sector.

Cost per Job

The grant cost per job for 2011 was €8,212 and the average cost per job over the past five years was €11,259. The cost per job reflects grant expenditure on capital, employment, research and development and training paid to client companies but excludes FIFG (Financial Instrument for Fisheries Guidance) and R&D&I funding. Other expenditure on training and education is excluded as there is no direct link between a substantial proportion of the expenditure on third level education courses and lifelong learning support schemes and the current year job creation programmes.

The ABSEI study surveyed companies that include approximately 75% of Údarás-supported employment and illustrates that Údarás na Gaeltachta client companies make a significant contribution to the Irish economy.

Punann Maoine

Ag deireadh 2011 bhí punann leathan maoine os cionn 240,000 méadar cearnach á bhainistiú ag Údarás na Gaeltachta ar fud na Gaeltachta i seacht gcontae éagsúla. Bhí 60% faoi thionónachtatá, timpeall 2% in áirithe do thionónaití úra, 20% a raibh gá athchóiriú a dhéanamh air agus timpeall 18% ar fáil do thionónaití úra. Léiríonn éagsúlacht na punainne maoine an ról leathan atá ag Údarás na Gaeltachta mar ghníomhaireacht forbartha réigiúnaí. Ní hé amháin go bhfuil sealúchas substaintiúil de pháirceanna gnó, monarchana agus ofigí sa phunann maoine, tá ceithre aerstráice ann freisin mar aon le seirbhísí coimhdeacha, agus raon maoine a coimisiúnaíodh go speisialta.

Ba ghné uathúil díolacháin a bhí ann san am a chuaigh thart go raibh ar chumas an Údarás infraestructúr fiontraíochta a fhorbairt agus réitigh lándéanta a sholáthar chun riachtanais na gcliant a shásamh agus tá sé seo ríthábhachtach chun cuidiú leis an eagráocht infheistíocht dhíreach dhúchasach agus eachtrach a mhealladh agus fostáiocht a chruthú sma ceantair is iargúltá. Tá forbairt agus soláthar áiseanna nua agus nua-aimseartha srianta go mór le blianta beaga anuas de bharr ciorruithe ar bhuiséad caipítí na heagraíochta.

Leanadh leis an gclár díolacháin maoine agus in ainneoin na géarchéime eacnamaíochta agus cúlú sa mhargadh, díoladh luach €1.86 milliún de mhaoín an Údarás le linn 2011. Bhí idirbheartaíocht ar siúl maidir le luach €3.4 milliún eile ag deireadh na bliana.

Property Portfolio

At 2011 year end, a substantial property portfolio of over 240,000 square metres located throughout the Gaeltacht in seven different counties was being managed by Údarás na Gaeltachta. A total of 60% was occupied by business or industrial tenants, 2% had already been committed to new prospective tenants, 20% required upgrading and 18% was available for new industry/businesses. The diversity of its property portfolio reflects Údarás na Gaeltachta's diverse role as a regional development agency. The portfolio includes not only a substantial holding of business parks, factories and office premises but also four airstrips with ancillary services and a range of specifically commissioned properties.

The ability of An tÚdarás to develop enterprise infrastructure and to provide turn-key solutions to meet clients' requirements has been a unique selling point in the past and is crucial in helping the organisation to attract indigenous and foreign direct investment and create employment in the most peripheral areas. The development and provision of new and modern enterprise facilities has been severely restricted in recent years due to budgetary capital expenditure restrictions.

The programme of disposal of property continued in 2011 and, despite the economic crisis and the credit squeeze, €1.86 million was realised from the sale of property during the year. A further €3.4 million of sales was under active negotiation at year end.

Gníomhaíochtaí Oideachais, Pobail agus Cultúrtha

Aithníonn an tÚdarás go bhfuil ról freagrachta aige pobal agus cultúr na Gaeltachta a threisiú agus a chinntí go bhfuil seirbhísí agus áiseanna oideachais, sóisialta agus cultúrtha den scoth ar fáil sa Gaeltacht a chuirfidh ar chumas phobal na Gaeltachta caighdeán saoil agus stíl mhaireachtála trí Ghaeilge a bheith acu atá ar aon dul lena gcomhshaoránaigh ar fud na tire.

Chun na haidhmeanna sin a bhaint amach, tá réimse de thionscnamh agus scéimeanna á reáchtáil agus á riarradh ag an Údarás atá dírithe ar chur chun cinn phobal na Gaeltachta i gcúrsaí oideachais agus oiliúna, forbairt pobail, na healaíona agus cultúr na Gaeltachta.

Oideachas agus Oiliúint

I rith na bliana 2011, rinneadh maoiniú ar chlár forbartha oiliúna áitiúil i ngach ceantar Gaeltachta chun roinnt tionscnamh oideachais agus oiliúna a sholáthar i dtaca le cuspóirí forbartha pobail agus fionraiochta an Údarás a bhaint amach.

Tacaíonn na scéimeanna forbartha oiliúna agus oideachais atá ar fáil le huasghrádú agus athoiliúint a dhéanamh ar scileanna dhaoine san fhóra

saothair, chomh maith le deiseanna traenála a sholáthar do dhaoine atá ag dul isteach sa mhargadh saothair don chéad uair trí scéimeanna ar nós Scéim na bPrintíseachtaí agus an Scéim Forbartha Bainistíochta.

Is cuid dílis de straitéis oiliúna agus oideachais an Údarás forbairt a dhéanamh ar an oideachas tríú leibhéil trí Ghaeilge sa Ghaeltacht lena chinntí go bhfuil linn láidir daoine ardoilte á soláthar d'fhórsa saothair Gaeltachta. Tá maoiniú á chur ar fáil ag an Údarás do roinnt institiúidi tríú leibhéil a bhfuil ceantair Ghaeltachta ina gceantar feidhme le cúrsáid creidiúnaithe diplóma, ard-dioplóma, céime agus iarchéime a chur ar fáil.

Le linn 2011:

- Bronnadh 18 scoláireacht phrintíseachta i gceirdeanna éagsúla faoi Scéim na bPrintíseachtaí. Ag deireadh na bliana bhí 98 duine ag staideanna éagsúla dá gcuid printíseachtaí urraithe ag an Údarás;
- Bhain 18 duine tairbhe as an Scéim Forbartha Bainistíochta agus an Scéim Taithí Oibre a dhíriónn ar thaithí oibre phraitimí a chur ar fáil do dhaoine atá críochnaithe le coláiste agus/nó atá ag lorg taithí le filleadh ar obair;
- Rinneadh maoiniú ar chúrsaí a sholáthair Institiúid Theicneolaíochta Phort Láirge i gcomhar le Nemeton Teo sa Rinn agus Institiúid Theicneolaíochta na Gaillimhe-Mhaigh Eo i gcomhar le hEuropus Teo i gCarna.

Education, Community and Cultural Activities

An tÚdarás recognises that it has an important role in supporting the Gaeltacht culture and community and in ensuring the provision of educational, social, cultural services and facilities in the Gaeltacht so that the Gaeltacht community may enjoy the same quality of life and lifestyle as its fellow citizens nationally.

To achieve these objectives, An tÚdarás organises and administers a range of initiatives and schemes in relation to education and training, community development, the arts and Gaeltacht culture.

Education and Training

During 2011, funding was provided for local training and education development initiatives in all Gaeltacht areas aimed at realising the community and enterprise development objectives of An tÚdarás.

These education and training development schemes support the upgrading and retraining of the Gaeltacht workforce, and also provide training opportunities for people entering the labour market for the first time through schemes such as the Apprenticeship Scheme and the Management Development Scheme.

The development of third level education through Irish in the Gaeltacht is an integral part of An tÚdarás' education and training strategy to ensure that a highly skilled workforce is available in the Gaeltacht. An tÚdarás provided funding to a number of third level institutions which have Gaeltacht areas within their catchment regions, for the provision of accredited diploma, higher diploma, degree and post-graduate courses.

During 2011:

- A total of 18 apprentice scholarships were awarded in various trades under the Apprenticeship Scheme. At year end there were 98 apprentices at various stages of their training on Údarás-funded apprenticeships;
- 18 people benefited from the Management Development Scheme and Work Experience Scheme which aim to provide practical work experience for third level graduates and/or people seeking experience to return to work;
- Funding was provided for courses delivered by the Waterford Institute of Technology in association with Nemeton Teo in An Rinn and by Galway Mayo Institute of Technology in association with Europus Teo in Carna.

Forbairt Pobail

Aithníonn an tÚdarás go bhfuil forbairt pobail mar chuid dílis d'fhorbairt na Gaeltachta agus chuige sin tá gníomhaíochtaí ar leith ar bun ag an Údarás atá dírithe go sonrach ar fhorbairt pobail.

Scéimeanna Fostaíochta Sóisialta

Déanann Údarás na Gaeltachta raon scéimeanna fostaíochta sóisialta a riadaradh sa Ghaeltacht. Tá na scéimeanna maoinithe go náisiúnta ag an Roinn Coimirce Sóisialaí agus b'fhiú €15 milliún san iomlán na scéimeanna do gheilleagar na Gaeltachta in 2011. Bhí breis agus 900 rannpháirtí agus 45 saoiste fostaithe ar scéimeanna ar fud na Gaeltachta. Mar aon le taithí oibre agus oilíúint a chur ar fáil dóibh siúd atá as obair, tá ról lárnach ag na scéimeanna i ngníomhaíochtaí forbartha pobail sa Ghaeltacht.

- Tá an Scéim Fostaíochta Pobail á riadaradh sa Ghaeltacht ag an Údarás i gcomhar leis na pobail áitiúla agus é mar aidhm taithí oibre a chur ar fáil, feabhas a chur ar shaol an cheantair agus misneach a thabhairt don phobal áitiúil. I rith 2011 chríochnaigh 143 rannpháirtí na scéimeanna agus fuair cuid acu seo fostaíocht lánaimseartha. Ag deireadh na bliana bhí 360 rannpháirtí agus 19 saoiste fostaithe ar 18 scéim.

- Ghlac an tÚdarás riadarachán na Scéime Tionscnamh Jabanna ar láimh i rith na bliana. Bhí 25 rannpháirtí agus saoiste amháin fostaithe ar an scéim seo ag deireadh na bliana.
- Tá an Scéim Shóisialta Tuaithe á riadaradh ag Údarás na Gaeltachta sa Ghaeltacht. Ag deireadh na bliana bhí 20 scéim ar an bhfód faoi scáth an Údarás ag fostú 452 rannpháirtí agus 21 saoiste.
- Tá an Scéim Tús á riadaradh ag Údarás na Gaeltachta sa Ghaeltachta chomh maith. Ag deireadh na bliana bhí 72 rannpháirtí agus ceathair saoistí fostaithe ar cheithre scéim.

Na hEagrais Phobail

Tá maoiniú tríd an Scéim Deontas Reáchtála á chur ar fáil ag Údarás na Gaeltachta do 29 eagrás pobail (comharchumainn agus comhlachtaí pobalbhunaithe) sa Ghaeltacht. Cuireann na heagras phobalbhunaithe seo, ina bhfuil 112 duine fostaithe, cláir leathan i bhfeidhm a chlúdaíonn gníomhaíochtaí forbartha pobail, bainistiú scéimeanna/tionscnamh agus caomhnú agus neartú na Gaeilge agus an chultúir Ghaelaigh. Tá pleán oibre ag gach eagraíocht agus bíonn spriocanna sonracha aontaithe leis an Údarás mar chuid den chomhaontú ar mhaoiniú.

Scéim Fiontar Pobail

Cuireadh maoiniú ar fáil tríd an Scéim Fiontar Pobail do 30 eagraíocht/coiste pobail chun cuidiú leo gníomhaíochtaí forbartha pobail a chur chun cinn

Community Development

Údarás na Gaeltachta recognises that community development is a core element of the development process in the Gaeltacht and it administers many specific activities aimed at community development.

Social Employment Schemes

Údarás na Gaeltachta administers a number of social employment schemes in the Gaeltacht. These schemes are funded nationally by the Department of Social Protection and were worth €15 million in total to the Gaeltacht economy in 2011. In excess of 900 participants and 45 supervisors were employed on schemes throughout the Gaeltacht. In addition to providing work experience and training for those out of work, these employment schemes play an important role in community development activities throughout the Gaeltacht.

- An tÚdarás in co-operation with local communities administers the Community Employment Schemes in the Gaeltacht with the aim of providing work experience, improving the fabric of community life and maintaining local morale. During 2011, 143 participants completed the schemes and the majority of them took up full-time employment thereafter. At year end there were 360 participants and 19 supervisors employed on 18 schemes.

- During the year, An tÚdarás took over the administration of the Jobs Initiative Scheme. At year end, there were 25 participants and one supervisor employed on this scheme.
- The Rural Social Scheme is administered by Údarás na Gaeltachta in the Gaeltacht. At year end there were 20 schemes in operation, employing 452 participants and 21 supervisors.
- An tÚdarás now also administers the Tús Programme in the Gaeltacht. At year end there were 72 participants and 4 supervisors employed on four schemes.

Community Organisations

An annual administration grant was paid to 29 community organisations (co-operatives and community-based companies) throughout the Gaeltacht under the Community Co-operatives Administration Grant Scheme. These community-based organisations, which employ 112 people, implement extensive work programmes consisting of community development activities, managing schemes/initiatives and assisting in the maintenance and preservation of the Irish language and culture. A programme of work is agreed with each organisation as part of the funding agreement.

Community Enterprise Scheme

Funding was provided for 30 community organisations/committees through the Community Enterprise Scheme to support the promotion of community development activities and the development of planning and management skills of committee members to assist in the preparation of development plans.

Tá Muintearas Teo, atá á mhaoliniú chun cuspóirí áirithe oideachais, teanga agus forbartha daonna a bhaint amach, ag cur béime den chuid is mó ar mhaolú ar an míbhuntáiste sa sóláthar oideachais/oiliúna Gaeltachta, ar chothromáiocht deiseanna a bhaint amach don Ghaeltacht agus ar an nGaeilge mar mheán teagaisc san oideachas Gaeltachta a threisiú. Áiritear na réimsí seo a leanas mar phríomhréimsí oibre an chomhlachta - luathfhorbairt an linbh, an réimse oideachais, an óige, cúrsai nuatheicneolaíochta, cumarsáide agus oideachas fadsaoil pobail. Tá an Roinn Oideachais agus Scileanna, an Roinn Ealaín, Oidhreachta agus Gaeltachta, FÁS, POBAL agus cláir de chuid an Aontais Eorpaigh mar fhoinsí maoinithe do réimsí éagsúla tionscadail atá á n-eagrú ag Muintearas.

An tAosach

Lean an túdarás ar aghaidh lena pholasáí chun an bonneagar sóisialta a fhorbairt sa Ghaeltacht. Mar chuid de pholasáí caomhnaithe teanga na heagraíochta, cuireadh tacaíocht ar fáil, tríad na scéimeanna fostaochta, do na hionaid lae chun tacú leo seirbhísí breise a sholáthar don aosach. Reáchtáladh réimse de chúrsai i gcúram aosach i gcompháirtíocht le Feidhmeannacht na Seirbhise Sláinte, Coiste Gairmoideachais na Gaillimhe agus Cumann Cúramóiri na hÉireann.

Muintearas Teo

Funded to implement educational, language and personal development programmes, Muintearas Teo's focus is largely on reducing disadvantage in Gaeltacht education/training provision, on achieving equality of opportunities for the Gaeltacht communities and reinforcing Irish as a teaching medium in Gaeltacht education. The company's primary focus is early childhood development, education, youth, new technology and communications as well as lifelong learning courses. The Department of Education and Skills, the Department of Arts, Heritage and the Gaeltacht, FÁS, POBAL and a number of European Union programmes are sources of funding for various initiatives being administered by Muintearas Teo.

The Elderly

An túdarás further progressed its policy of developing social infrastructure in the Gaeltacht. As part of the organisation's language maintenance policy, support was provided to day-centres to enable them to provide additional services for the elderly. A number of Carers' courses for those dealing with the elderly were organised in association with the Health Service Executive, the Vocational Education Committee, Galway, and the Carers' Association of Ireland.

Na hEalaíona

Déanann Údarás na Gaeltachta agus An Chomhairle Ealaón cómhaoiniú ar chlár forbartha agus cothaithe na n-ealaíon traidisiúnta agus comhaimseartha trí fhochuideachta de chuid an Údarás, Ealaín (na Gaeltachta) Teo. Tá triúr áiséitheoirí réigiúnacha fostaithe ag an gcomhlacht leis an gclár a chur i bhfeidhm.

Buaiceanna 2011

Tugadh tacaíocht do 88 togra ealaíon faoi scéimeanna maoinithe Ealaín na Gaeltachta le linn 2011. Seo a leanas an briseadh síos de réir scéime:

Scéim Forbartha na nEalaíon - trína dtugtar tacaíocht do dhaoine aonair nó d'eagrais ar mian leo tionscnamh ealaíon a fhorbairt. Ceadaíodh tacaíocht do 21 tionscnamh ealaíon faoin scéim seo le buiséad iomlán de €116,000;

Scéim na bhFéilte Ealaíon - trína dtugtar tacaíocht do dhaoine aonair nó d'eagrais ar mian leo féile ealaíon a fhorbairt. Cuireadh tacaíocht ar fáil do 16 féile Gaeltachta in 2011, le buiséad iomlán de €87,000;

Scéim Sparánachta d'Ealaíontóirí - trína dtugtar deis d'ealaíontóirí aonair iarratas a dhéanamh ar mhaoliniú a chuirfidh ar a gcumas tréimhse ama a chur i leataobh le forbairt a dhéanamh ar a gceird. Cuireadh 47 iarratas faoi bhráid in 2011 agus ceadaíodh tacaíocht do 36 ealaíontóir le buiséad iomlán de €50,000;

The Arts

Údarás na Gaeltachta and the Arts Council jointly fund a wide range of traditional and contemporary arts initiatives and projects through an Údarás subsidiary company Ealaín (na Gaeltachta) Teo. This company employs three regional arts facilitators who implement the programme.

2011 Highlights

During 2011, support was granted to 88 arts initiatives through schemes facilitated by Ealaín na Gaeltachta which are detailed as follows:

The Arts Development Scheme – supports individuals or organisations wishing to develop arts projects. Support was approved for 21 initiatives under this scheme in 2011 amounting to a total budget approval of €116,000;

The Arts Festivals Scheme – supports individuals or organisations wishing to develop an arts festival. Support was approved for 16 Gaeltacht festivals in 2011 amounting to a total budget approval of €87,000;

The Bursary Scheme for Artists – provides an opportunity for individual artists to apply for funding, therefore enabling them to take time off to develop their skills. 47 applications were submitted in 2011 and assistance was approved for 36 artists amounting to a total budget approval of €50,000;

The Main Activities Scheme – allows for strategic development in various aspects to enhance the arts infrastructure on a long term basis. Assistance

Is éard a bhí sa mhórthaispeántas ná ilteilgín lasmuigh de shaothar ealaontóiri, atá lonnaithe sa Ghaeltacht nó go bhfuil nasc leis an nGaeltacht acu. Léiríodh an togra sa Daingean, i mBaile an Sceilg, sa Spidéal, i nGaoth Dobhair agus sa Dáilann Náisiúnta i mBaile Átha Cliath ar an oíche.
- Bhí an taispeántas ‘Tír’ le físealaintóiri as Éirinn, Albain agus an Bhreatain Bheag páirteach, ar chamchuaireacht in 2011. Bhí an taispeántas mar thoradh ar thréimhse cónaithe ealaontóiri ón mBreatain Bheag, Albain agus an Ghaeltacht, a chaith dhá mhí ina gcónai sna tiortha ‘Comharsana Ceilteacha’ ag forbairt a saothar agus ag obair leis an bpobal ar thograí ealaíon. D’eascair an togra seo as an gcompháirtíocht leis na ‘Comharsana Ceilteacha’ lena bhfuil Ealaín na Gaeltachta páirteach le sé bliana anuas.
- Bhí ócáid stairiúil i gcúrsaí drámaíochta na Gaeilge in 2011 nuair a léirigh Fíbín an dráma Sétanta i gcomhar le hAmharclann na Mainistreach i mí na Nollag 2011. Ba é seo an chéad uair ag compántas

was approved for 15 projects under this scheme in 2011 amounting to a total budget approval of €312,000.

Other Activities

- The Gaeltacht participated in the national event ‘Culture Night’ for the second year running. In excess of 30 events were organised throughout the Gaeltacht and the artist Andrew Duggan curated a multi-location exhibition, *Crosbhóthar*, a large outdoor projection piece featuring work by more than 80 visual and text based artists from throughout the entire Gaeltacht. It was presented simultaneously in various Gaeltacht locations, An Daingean, Baile an Sceilg, An Spidéal, Gaoth Dobhair and on the walls of the National Gallery, Dublin.
- The exhibition *Tír* featuring visual artists from Ireland, Scotland, and Wales was on tour during 2011. The exhibition was the outcome of a two month residential period spent by artists from Scotland, Wales and the Gaeltacht in the *Comharsana Ceilteacha* countries developing their work and working on art projects with the community. This initiative resulted from a partnership with *Na Comharsana Ceilteacha* with which Ealaín na Gaeltachta has been involved over the last six years.
- A historical event in Irish drama took place in 2011 when the play *Sétanta* was produced by Fíbín in conjunction with the Abbey Theatre in December 2011. This was the first time an Irish drama had been staged by a Gaeltacht theatre company in partnership with the country’s national theatre.

Gaeltachta dul i gcompháirt le hAmharclann Náisiúnta na tire le dráma Gaeilge a chur ar státse.

- Mar thoradh ar thacaíocht agus spreagadh ó Ealaín na Gaeltachta, cuireadh tú le tograí scéalaíochta nua rathúla sa Ghaeltacht, ‘Gliondar’ agus ‘Scéal Scéal Scéal’ i gConamara, agus ‘Ó Bhéal go Béal’ le Gearóidín Breathnach i nDún na nGall. Tográi tábhachtacha iad seo leis an scéalaíocht a phorbairt, réimse ealaíne a bhfuil a thábhacht i mbaol agus le cothú. Dhírígh ionad Cultúrtha Bhaile Bhuirne ar dhúchas Mhúscaí tríd an scéim lúibíní agus agallamh beirte ‘Béal Beo’ a chur ar fáil d’ógánaigh an cheantair. Deimhníonn scéimeanna den saghas seo ó cheann ceann na Gaeltachta, go mairidh an tseanealaín i measc na glúine óige, a dhéanfaidh aithris dá gcuid féin ar thraidisiún a muintire.
- Chuir breis agus 150 duine isteach ar Chomórtas Liteartha an Údarás in 2011, méadú 35% ar an mbliaín roimhe sin. Bhí caighdeán ard ag baint leis na hiarratais agus is toradh é seo ar dhea-obair thograí litríochta na Gaeltachta atá maoinithe agus cothaithe ag Ealaín na Gaeltachta le breis agus deich bliana anuas. Bronnadh 23 duais litríochta ar rannpháirtithe an Chomórtais.
- Reáchtáil Ealaín na Gaeltachta sraith cursaí oiliúna i rith na bliana diríthe ar ealaín agus ar chúrsaí forbartha gnó.

- With the help and support of Ealaín na Gaeltachta, the successful storytelling initiatives *Gliondar* and *Scéal Scéal Scéal* commenced in Conamara, and *Ó Bhéal go Béal* by Gearóidín Breathnach in Donegal. These are important initiatives to develop the art of storytelling, an area of art which is at risk and in need of preservation. The cultural centre in Baile Bhuirne focused on Múscaí by delivering the *Béal Beo* scheme, a dialogue in verse and rhymes scheme, for the youth in the area. Schemes of this type throughout the Gaeltacht ensure that traditional art will survive amongst the youth, who will continue to practice the traditions of their predecessors.
- In excess of 150 people entered the Údarás Creative Writing Competition in 2011, an increase of 35% on the previous year. The entries were of very high standard, and this was as a result of the excellent work of Irish literature initiatives funded and maintained by Ealaín na Gaeltachta over the last ten years. Twenty three literature prizes were awarded to entrants.

A series of training courses were organised by Ealaín na Gaeltachta Teo throughout the year aimed at art and business development.

Gníomhaíochtaí Gaeilge

Is é príomhaidhm reachtúil an Údarás ná caomhnú agus leathadh na Gaeilge mar theanga phobail agus teaghlaigh. Tá cothabháil agus forbairt na teanga mar chuid lárnach de ghníomhaíochtaí na heagraíochta agus chuige sin curtear scéimeanna agus tionscnamh áirithe i bhfeidhm chun tabhairt faoi na dúshlán teanga.

Ionad Seirbhísí Teanga

Tá 34 ionad bunaithe ag an Údarás ar fud na Gaeltachta i gcomhar le heagrais phobail. D'fhreastail os cionn 400 ar chúrsaí sna hionaid sin in 2011 agus tá thart ar 70 de na foghlaimeoirí seo ag déanamh scrúdúithe creidiúnaithe ar nós dioplóma tríú leibhéal nó Teastas Eorpach na Gaeilge (TEG).

Scéim Ghaeilge do Chomhlachtaí Gaeltachta

I rith na bliana, d'aontaigh an tÚdarás pleannanna spriocanna teanga le 30 dá chuid cliantchomhlachtaí faoin scéim seo. Tá an scéim tacaíochta deartha go speisialta leis an nGaeilge a spreagadh i measc chlianachomhlachtaí sa Ghaeltacht le béim faoi leith ar úsáid agus infheictheacht na Gaeilge i gcúrsaí gnó, ach go háirithe.

Luathoideachas

Bhí 75 naónra ag feidhmiú ar fud na Gaeltachta, ag freastal ar bhreis agus 1,000 páiste le linn 2011. Is é Comhar Naónraí na Gaeltachta Teo, atá á

mhaoiniú ag an Údarás, an struchtúr neamhspleách a dhéanann naónraí pobail na Gaeltachta a riadar agus a bhainistiú. Tá seisear fostaithe go lánameartha agus 129 fostaithe go páirtaimseartha ag Comhar Naónraí na Gaeltachta Teo. Bhí 12 ionad cúram leanaí ag feidhmiú sna Gaeltachtaí éagsúla le linn na bliana agus tá ceann eile le hoscailt in 2012. Chuir Comhar Naónraí na Gaeltachta seirbhísí ar fáil do sé cinn acu.

An Óige

Cuireann Údarás na Gaeltachta maoiniú ar fáil d'Óige na Gaeltachta Teo chun imeachtaí óige a reáchtáil sna Gaeltachtaí éagsúla. Bhí 57 club óige ag feidhmiú ar fud na Gaeltachta agus breis agus 2,000 ógánach cláraithe ag Óige na Gaeltachta Teo in 2011. Osclaíodh dhá ionad nua buail isteach nua i rith 2011, ceann i gCill Charthaigh agus an ceann eile i Ráth Chairn. Tá ceathrar fostaithe ag Óige na Gaeltachta Teo agus tá oifigí acu sa Ghaeltacht san iarhar, sa tuaisceart agus sa deisceart.

Irish Language Activities

The primary statutory objective of Údarás na Gaeltachta is the preservation and extension of the Irish language as a community and family language. All of the organisation's activities have at their core a language maintenance and development objective and to that end specific schemes and initiatives are implemented to address the challenges in relation to language maintenance.

Language Services Centres

34 Irish Language Services Centres have been established throughout the Gaeltacht with the support of Údarás na Gaeltachta. Over 400 people attended Irish language courses in these centres in 2011 and approximately 70 of these learners are undertaking accredited examinations such as a third level diploma or the European Irish Language Certificate (TEG).

Irish Language Initiative for Businesses

An tÚdarás agreed language plans and objectives with 30 of its client companies during the year. The support scheme has been devised specifically to promote the Irish language in Údarás client companies in the Gaeltacht with special emphasis on the visibility and use of Irish in business.

Early Childhood Education

There were 75 preschools (naónraí) operating throughout the Gaeltacht and catering for in excess of 1,000 children during 2011. Comhar Naónraí


na Gaeltachta Teo is the independent structure funded by Údarás na Gaeltachta to administer and manage naónraí throughout the Gaeltacht. Comhar Naónraí na Gaeltachta Teo employs six fulltime and 129 part-time staff. There were 12 childcare centres in operation throughout the various Gaeltacht areas during the year and another one is due to open in 2012. Comhar Naónraí na Gaeltachta Teo provided services for six of these centres.

Youth

Údarás na Gaeltachta provides funding for the youth organisation Óige na Gaeltachta Teo to organise youth activities in the various Gaeltacht areas. There were 57 youth clubs in operation throughout the Gaeltacht with over 2,000 members registered in 2011. Two new drop in centres were opened in 2011, one in Cill Charthaigh and the other in Ráth Chairn. Óige na Gaeltachta Teo employs four people and has regional offices in the west, north and south Gaeltacht areas.

Organisation and Services



Rialachas Corporáideach

Is comhlacht corporaithe é Údarás na Gaeltachta arna bhunú ag an Acht um Údarás na Gaeltachta, 1979, agus feidhmíonn sé de réir forálacha na nAchtanna um Údarás na Gaeltachta, 1979 go 2010 faoi shainchúram na Roinne Ealaíon, Oidhreachta agus Gaeltachta. Chomh maith lena chuid reachtaíochta rialaithe féin, tá dualgas ar an Údarás freisin cloí le raon de cheanglais reachtúla agus riarracháin eile de chuid an Stáit agus an Aontais Eorpach.

Foireann

Ag deireadh 2011 bhí 95 duine fostaithe ag an Údarás.

Fad a bhí todhchaí an Údarás faoi chaibidil le linn na bliana, go háirithe i gcomhthéacs na Straitéise 20 Bliaín don Ghaeilge 2010-2030, ceadaíodh don Údarás Príomhfeidhmeannach Eatramhach a cheapadh ar feadh na bliana 2011. Lean an plé leis an Roinn Ealaíon, Oidhreachta agus Gaeltachta in 2011 freisin maidir le riachtanais don phost seo agus d'eochairphoist eile san eagraíocht.

Comhionannas

Tá Údarás na Gaeltachta tiomanta go hiomlán do pholasáí comhionannais deise, agus tá gach post san eagraíocht oscailte d'fhir agus do mhnr. Leanfar leis na scéimeanna atá ag an Údarás le roghanna a chur ar fáil don fhoireann i dtaca leis na riachtanais ghairme agus phearsanta atá acu, nithe mar chomhroinnt poist, sosanna gairme, saoire speisialta agus uaireanta laghdaithe oibre. I rith na bliana 2011, bhain naoi nduine dhéag den fhoireann leas as na scéimeanna seo.

Corporate Governance

Údarás na Gaeltachta is a corporate body established by the Údarás na Gaeltachta Act, 1979, and it operates in accordance with the provisions of the Údarás na Gaeltachta Acts, 1979 to 2010 under the aegis of the Department of Arts, Heritage and the Gaeltacht. In addition to its own governing legislation, the agency is also required to comply with a range of other State and EU statutory and administrative requirements.

Staff

At the end of 2011 there were 95 persons employed in the organisation.

As the future of An tÚdarás was under consideration during the year, in particular in the context of the 20-Year Strategy for the Irish Language 2010-2030, An tÚdarás was permitted to appoint an Interim Chief Executive for the year 2011. Discussions also continued in 2011 with the Department of Arts, Heritage and the Gaeltacht regarding the requirements for this and other key posts in the organisation.

Equality

Údarás na Gaeltachta is committed to a policy of equal opportunity and has developed an equality programme over the years. An tÚdarás continues to operate a number of schemes which provide staff with options in relation to meeting their career and personal needs, such as job sharing, career breaks and reduced working hours. During 2011, 19 staff availed of these schemes.

Déanann an tÚdarás athbhreithniú ar na Ráitis Shábháilteachta go leanúnach chun a chinntíú go bhfuiltear ag cloí go hiomlán leis na forálacha atá san Acht um Shábháilteacht, Sláinte agus Leas ag an Obair, 2005.

Leanadh le hoiliúint a chur ar fáil don fhoireann i réimsí sábháilteachta agus sláinte i rith 2011 chun féachaint chuige go bhfuil an tÚdarás ag comhlíonadh na bhforálacha reachtúla.

Leanadh le forbairt agus oliúint foirne in 2011. Within the constraints applying to the recruitment of staff in the Public Service in general, efforts are made to make suitable job opportunities available to people with disabilities.

The Safety, Health and Welfare at Work Act, 2005

In accordance with the Safety, Health and Welfare at Work Act, 2005, Údarás na Gaeltachta has a written safety statement and continues to implement appropriate measures to protect the safety and health of all employees and visitors at its places of business. An tÚdarás continuously reviews all safety statements to ensure compliance with the provisions of the Safety, Health and Welfare at Work Act, 2005.

During 2011 staff training in various areas of Health and Safety continued in order to ensure the organisation is fully compliant with legislation.

Staff Training and Development

The staff training and development programme continued in 2011. Members of staff attended a wide range of courses during the year which included day courses, diploma, degree and masters courses in business, management, law, renewable energy, language planning, the Irish language, finance and new technology.

Client Care Programme

In accordance with good practice in the Public Service, Údarás na Gaeltachta has adopted a Code of Practice for Quality Client Care. The Client Charter is displayed and available in Údarás offices and on its website www.údarás.ie.

Tháinig Údarás na Gaeltachta faoi thionchar an Acharta um Shaoráil Faisnéise ar 21 Eanáir 2001. I rith 2011 fuair an tÚdarás cúig iarratas ar thaifid. Níor iarradh aon athbhreithniú inmheánach.

udaras.ie. The Code of Practice includes procedures for handling disputes and a system for dealing with formal complaints regarding the quality of An tÚdarás' service delivery. Normal procedures are followed for investigating and responding to representations and complaints and to correct any issues as they arise. An tÚdarás continues to place emphasis on improving services to its clients, and to that end procedures are amended and documented as appropriate, to ensure consistent delivery of service.

Under the Public Service Agreement (Croke Park Agreement), An tÚdarás has developed an action plan to support the maintenance of high quality public services in an environment where resources and staff numbers are being significantly reduced. The Údarás action plan and progress reports are available to download from its website.

The Ethics in Public Office Acts, 1995 and 2001

In accordance with the Ethics in Public Office Acts, 1995 and 2001 members of the Board of Údarás na Gaeltachta and staff holding designated positions completed statements of interests as appropriate. Since 2009 the provisions of these Acts apply to the directors and certain managers in the Údarás subsidiaries, who also completed statements in 2011 as appropriate.

Freedom of Information Acts, 1997 and 2003

Údarás na Gaeltachta was brought under the provisions of the Freedom of Information Act on 21 January 2001. During 2011, An tÚdarás received five requests. There were no requests for internal review.

Rialacháin na gComphobal Eorpach (Rochtain ar Fhaisnéis faoin gComhshaol) 2007

D'fhoinn éifeacht a thabhairt do Threoir 2003/4/ CE Pharlaimint agus Chomhairle na hEorpa maidir le rochtain a bheith ag an bpobal ar fhaisnéis faoin gcomhshaol, thug an tAire Comhshaoil, Oidhreachta agus Rialtais Áitiúil Rialacháin isteach in Éirinn le héifeacht ó 1 Bealtaine 2007.

Forálann na Rialacháin, dar teideal Rialacháin na gComphobal Eorpach (Rochtain ar Fhaisnéis faoin gComhshaol), I.R. 133 de 2007, nach foláir faisnéis a bhaineann leis an gcomhshaol atá ina sheilbh ag údarás poiblí ar nós Údarás na Gaeltachta, nó atá coinnithe ar a shon, a chur ar fáil ar iarratas do dhuine ar bith, faoi réir eisceachtaí áirithe. Tá córas i bhfeidhm ag an Údarás le freagairt do riachtanais na Rialachán.

Mar eagraíocht a bhíonn ag plé le forbairt thionsclaíoch agus fostáiochta agus le cur chun cinn forbairt pobail, cultúir agus teanga, tá maoin ghnó ag Údarás na Gaeltachta sna contaetha Gaeltachta ar fad, idir thalamh, fhoirgnimh, eastáit tionscail agus pháirceanna gnó. I measc na gcineálacha faisnéise a bhíonn ina sheilbh bionn eolas faoi ionaid ghnó, eastáit agus pháirceanna gnó, cinn a bhfuil tionóntaí iontu san áireamh, eolas comhshaoil faoi thionscadail áirithe a dtugann an tÚdarás tacaíocht dóibh, staidéir tionchair imshaoil do chúrsaí pleinála, agus comhaid sláinte agus sábháilteachta. Ní athraíonn na Rialacháin seo na hAchtanna um Shaoráil Faisnéise agus feidhmíonn siadsan go comhthreomhar leis na Rialacháin seo.

European Communities (Access to Information on the Environment) Regulations 2007

With a view to giving effect to Directive 2003/4/EC of the European Parliament and Council on public access to environmental information, the Minister for the Environment, Heritage and Local Government introduced Regulations in Ireland with effect from 1st May 2007.

The Regulations, entitled the European Communities (Access to Information on the Environment) Regulations, S.I. 133 of 2007, provide that, subject to certain exceptions, information relating to the environment held by, or for, a public authority such as Údarás na Gaeltachta must be made available on request to any person. An tÚdarás has a system in place to meet the requirements of these Regulations.

As an organisation dealing with industrial and employment promotion and with community, language and cultural development, Údarás na Gaeltachta has property portfolios in each of the Gaeltacht counties, including land, buildings, industrial estates and business parks. Among the types of information it holds are information on business premises, estates and business parks, including properties let to tenants, environmental information on certain projects supported by An tÚdarás, environmental impact studies for planning purposes and health and safety files. The Freedom of Information Acts are not affected and they continue to operate in parallel with these Regulations.

An tAcht um Íoc Pras Cuntas, 1997

Baineann an tAcht um Íoc Pras Cuntas, 1997, a tháinig i bhfeidhm 2 Eanáir 1998, agus Rialachán na gComphobal Eorpach (Íocaíocht Dhéanach in Idirbhearta Tráchtála) 2002, a tháinig i bhfeidhm 7 Lúnasa 2002, leis an Údarás. Is é beartas an Údarás a chinntíú go n-íocatar gach sonrasc go pras, faoi réir dóthain cistí a bheith ar fáil. Tá forálacha sonracha i bhfeidhm a thugann deis gach sonrasc a rianú agus a chinntíú go ndéantar íocaíochtaí faoina ndáta dlite. Déantar tuairisc ar shonraisc ar bhonn laethúil agus déantar íocaíochtaí seachtainiúla lena chinntíú go ndéantar íocaíochtaí phras. Tá na forálacha seo deartha chun deimhniú réasúnta, cé nach deimhniú cinnte é, a thabhairt in aghaidh neamhchomhlíonadh an Achta agus na Rialachán.

De bhun cinneadh Rialtais, is gá d'eagraíochtaí Stáit neamhchráchtála, Údarás na Gaeltachta san áireamh, cloí le treoracha nua faoina n-íocatar soláthraithe laistigh de 15 lá ó fhaightear sonrasc bailí uathu ó 1 Iúil 2011. Foilsítear eolas ráithiúil ar chur i bhfeidhm an chinnidh seo ar shuíomh idirlín an Údarás www.udaras.ie. Seo a leanas achoimre den eolas sin do na sé mhí go 31 Nollaig 2011:

Code of Practice for the Governance of State Bodies

Údarás na Gaeltachta has put in place procedures to ensure that it fully complies with the Code of Practice for the Governance of State Bodies. The Cathaoirleach reports accordingly each year in a report to the Minister.

Prompt Payment of Accounts Act, 1997

Údarás na Gaeltachta comes under the remit of the Prompt Payment of Accounts Act, 1997, which came into effect on 2nd January 1998, and the European Communities (Late Payment in Commercial Transactions) Regulations 2002, which came into effect on 7th August 2002. It is the policy of Údarás na Gaeltachta to ensure that all invoices are paid promptly, subject to sufficient funds being available.

Specific provisions are in place to enable all invoices to be tracked and to ensure that payments are made by their due date. Invoices are logged daily and weekly payment runs are carried out to ensure prompt payment. These controls are designed to provide reasonable, though not absolute assurance against non-compliance with the Act and Regulations.

From 1 July 2011, in accordance with a Government Decision non-commercial State agencies, including Údarás na Gaeltachta, are obliged to pay suppliers within 15 days of receipt of a valid invoice. Quarterly reports are published on the Údarás website www.udaras.ie on the implementation of the decision. The following is a summary of that information for the six months to 31 December 2011:

Fuinneamh agus Comhshaol

Forbheathnú ar úsáid fuinnimh sa bhliain 2011

Is iad na príomh-úsáideoirí fuinnimh in Údarás na Gaeltachta ná oifigi na bhForbacha a úsáideann 79.1%, oifig Gaoth Dobhair ag úsáid 14.9% agus oifig an Daingin ag úsáid 6%. In iomlán, úsáidtear 62.1% den fhuinneamh i gcomhair teasa, aerchóiriú agus uisce te. Úsáideann soilsíú agus trealamh oifige 35.2% agus cócaireacht 2.7%.

In 2011, d'úsáid Údarás na Gaeltachta 887,157KWh d'fhuinneamh, sin ardú 5% ar an mbliain roimhe sin, agus bhí sin amhlaigh mar gur úsáideadh 48,000kWh d'fhuinneamh chun spás nua oifige 'deasc te' a théamh.

Energy and Environment

Overview of energy usage in 2011

The main energy users at Údarás na Gaeltachta are the offices in Na Forbacha which uses 79.1% of consumption, Gaoth Dobhair office using 14.9% and An Daingean using 6% of consumption. A total of 62.1% of the energy consumed is attributed to space heating, air conditioning and domestic hot water. Lighting and office equipment account for 35.2% while catering represents 2.7% of consumption.

In 2011 Údarás na Gaeltachta consumed 887,157KWh of energy which showed a marginal increase of 0.5% over the previous year attributed mostly to an additional annual heat energy load of 48,000 KWh for a new hot-desk area. The total energy consumed consisted of:

- 336,831KWh of electricity;
- 550,326KWh of fossil fuel which included 26,192KWh of LPG.

Energy saving actions undertaken in 2011

In 2011 Údarás na Gaeltachta undertook a range of initiatives to improve energy performance, including:

- The continuous monitoring of energy use in three staff occupied buildings;

- The installation of weather compensation devices to a heating system at our Gaoth Dobhair office resulting in an annual saving in heat energy of 6,635KWh;
- The improvement of window and door seals at Head office;
- The replacement of energy efficient lamps to luminaries throughout the three offices;
- The completion of the first stage procurement procedure for the installation of a biomass boiler to replace the existing oil fired boiler at Head office;
- A substantial annual reduction of 2,708KWh of LPG usage was achieved at the office in An Daingean;
- On average electricity consumption within two of our offices has continued to drop by an average of 4% with a massive drop of 40% shown for our Gaoth Dobhair office.

Actions planned for 2012

In 2012, Údarás na Gaeltachta intends to further improve its energy performance by undertaking the following initiatives:

- The continuous monitoring of energy consumption in three Údarás na Gaeltachta offices and corrective actions where spikes in usage are detected;

- Na hoifigí go léir a fheistíú le soilsíú tíosach ar fhuinneamh;
- Coire bithmhaise slisadh maid nua agus níos éifeachtaí a chur isteach san Ardoifig in ionad an choire olabreoslaithe 700KWh atá ann faoi láthair. Táthar ag súil leis an obair a bheith curtha i gcríoch roimh dheireadh na bliana. Chun éifeachtúlacht a fheabhsú agus chun caillteanas as na píopáí seachtracha a laghdú, tógfar amach na píopáí teasa seachtracha atá ann agus cuirfear isteach córas píopáí téamh ceantair inslite. Cuirfear isteach córas nua bainistíochta fuinnimh chomh maith.

Fostaíocht agus Íocaíochtaí



- Proceed with the installation of energy efficient lighting within all offices;
- The existing 700 KWh oil fired boiler at Head office will be replaced with a new and more efficient biomass woodchip boiler. It is our intention to have this work completed by the end of the year. All external heating piping will be replaced with a zoned factory insulated district heating pipe system to help improve efficiency and reduce external pipe losses. The installation will include a new energy management system.

Report of the Comptroller and Auditor General for presentation to the Houses of the Oireachtas

I have audited the financial statements of Údarás na Gaeltachta for the year ended 31 December 2011 under the Údarás na Gaeltachta Act, 1979. The financial statements, which have been prepared under the accounting policies set out therein, comprise the Accounting Policies, the Operating Account, the Statement of Total Recognised Gains and Losses, the Balance Sheet, the Cash Flow Statement and the related notes. The financial reporting framework that has been applied in their preparation is applicable law and Generally Accepted Accounting Practice in Ireland.

Responsibilities of the Members of An tÚdarás

The Members of An tÚdarás are responsible for the preparation of the financial statements, for ensuring that they give a true and fair view of the state of Údarás na Gaeltachta's affairs and of its income and expenditure, and for ensuring the regularity of transactions.

Responsibilities of the Comptroller and Auditor General

My responsibility is to audit the financial statements and report on them in accordance with applicable law.

My audit is conducted by reference to the special considerations which attach to state bodies in relation to their management and operation.

My audit is carried out in accordance with the International Standards on Auditing (UK and Ireland) and in compliance with the Auditing Practices Board's Ethical Standards for Auditors.

Scope of Audit of the Financial Statements

An audit involves obtaining evidence about the amounts and disclosures in the financial statements, sufficient to give reasonable assurance that the financial statements are free from material misstatement, whether caused by fraud or error. This includes an assessment of

- whether the accounting policies are appropriate to Údarás na Gaeltachta's circumstances, and have been consistently applied and adequately disclosed
- the reasonableness of significant accounting estimates made in the preparation of the financial statements, and
- the overall presentation of the financial statements.

I also seek to obtain evidence about the regularity of financial transactions in the course of audit.

In addition, I read all the financial and non-financial information in the Annual Report to identify material inconsistencies with the audited financial statements. If I become aware of any apparent material misstatements or inconsistencies I consider the implications for my report.

Opinion on the Financial Statements

In my opinion, the financial statements, which have been properly prepared in accordance with Generally Accepted Accounting Practice in Ireland, give a true and fair view of the state of Údarás na Gaeltachta's affairs at 31 December 2011 and of its income and expenditure for the year then ended.

- The Statement on Internal Financial Control does not reflect Údarás na Gaeltachta's compliance with the Code of Practice for the Governance of State Bodies, or
- I find there are other material matters relating to the manner in which public business has been conducted.

I have nothing to report in regard to those matters upon which reporting is by exception.

Statement of the Board's Responsibilities

Section 18 (1) of the Údarás na Gaeltachta Act, 1979 requires An tÚdarás to prepare financial statements in such form as may be approved by the Minister, with the concurrence of the Minister for Finance. In preparing those financial statements, An tÚdarás is required to:

- select suitable accounting policies and then apply them consistently;
- make judgements and estimates that are reasonable and prudent;
- prepare the financial statements on the going concern basis unless it is inappropriate to presume that the Údarás will continue in operation;
- disclose and explain any material departures from applicable accounting standards.

The Board is responsible for keeping proper accounting records which disclose with reasonable accuracy at any time the financial position of the company, and to enable it to ensure that the financial statements comply with Section 18 (1) of the Údarás na Gaeltachta Act, 1979. The Board is also responsible for safeguarding the assets of the company and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

- Disciplíní foirmiúla do bhainistíochta tionscadal.

Statement on Internal Financial Control

On behalf of the Board of Údarás na Gaeltachta, I acknowledge our responsibility for ensuring that an effective system of internal financial control is maintained and operated.

The system can only provide reasonable and not absolute assurance that assets are safeguarded, transactions authorised and properly recorded, and that material errors or irregularities are either prevented or would be detected in a timely period.

The Board has taken steps to ensure an appropriate control environment is in place by:

- Clearly defining management responsibilities and powers;
- Establishing formal procedures for monitoring the activities and safeguarding the assets of the organisation;
- Developing a culture of accountability across all levels of the organisation.

The Board has established processes to identify and evaluate business risks by:

- Identifying the nature, extent and financial implication of risks facing the body including the extent and categories which it regards as acceptable;
- Assessing the likelihood of identified risks occurring;
- Working closely with Government and various agencies to ensure that there is a clear understanding of Údarás na Gaeltachta's goals and support for the strategies to achieve those goals.

The system of internal financial control is based on a framework of regular management information, administration procedures including segregation of duties, and a system of delegation and accountability. In particular it includes:

- A comprehensive budgeting system with an annual budget which is reviewed and agreed by the Board of Údarás na Gaeltachta;
- Regular reviews by the Board of Údarás na Gaeltachta of periodic and annual financial reports which indicate financial performance against forecasts;
- Setting targets to measure financial and other performance;
- Clearly defined capital investment control guidelines;
- Formal project management disciplines.

Áirítear sa tuairisc sin tuairim na Seirbhise ar éifeachtach agus ar leordhóthanacht an chórais rialaithe airgeadais inmheánaigh.

Bíonn obair na Seirbhise Iníúchóireachta Inmheánaí, An Choiste Iníúchta a mhaoirsíonn obair na Seirbhise sin, bhainisteoír feidhmeannacha laistigh de Údarás na Gaeltachta atá freagrach as forbairt agus cothabhlí an chreat oibre rialaithe airgeadais, agus ráitis arna ndéanamh ag an Ard-Reachtaire Cuntas agus Ciste sa litir bhainistíochta, mar bhonn eolais don Bhord agus é ag déanamh monatóireachta agus athbhreithnithe ar éifeachtach an chórais rialaithe airgeadais inmheánaigh.

Dearbhaím go ndearna an Bord athbhreithniú ar éifeachtach an chórais rialaithe airgeadais inmheánaigh a bhí i bhfeidhm i rith na bliana 2011.

An Internal Audit Service is provided to Údarás na Gaeltachta which operates in accordance with the Framework Code of Best Practice set out in the Code of Practice on the Governance of State Bodies. The work of that Service is informed by analysis of the risk to which the body is exposed, and annual internal audit plans are based on this analysis. The analysis of risk and the internal audit plans are endorsed by the Audit Committee. At least annually, the Internal Audit Service provides the Audit Committee with a report of internal audit activity. The report reflects the opinion of the Internal Audit Service on the adequacy and effectiveness of the system of internal financial control.

The Board's monitoring and review of the effectiveness of the system of internal financial control is informed by the work of the Internal Audit Service, the Audit Committee which oversees the work of that Service, the executive managers within Údarás na Gaeltachta who have responsibility for the development and maintenance of the financial control framework and comments made by the Comptroller and Auditor General in the management letter.

I confirm that the Board carried out a review of the effectiveness of the system of internal financial controls in operation during 2011.

(a) Bunús Cuntasáiochta

Uillmhaíodh na ráitis airgeadais seo de réir alt 18 den Acht um Údarás na Gaeltachta, 1979 faoi mhodh fabhrainne cuntasáiochta, seachas mar a léirítéar thíos, agus de réir prionsabail chuntasáiochta a nglactar leo go ginearálta faoin gcoinbhinsiún costais stairiúil. Glactar le Caighdeán Tuairiscithe Airgeadais arna moladh ag na comhlachtaí aitheanta cuntasáiochta, de réir mar a thagann siad i bhfeidhm.

(b) Deontais an Oireachtas, Cistí Struchtúrtha an AE agus Aisíocaíochtaí Deontas agus Díbhinní

Comhairtear na nithe seo ar bhonn fáiltais airgid thirim.

(c) Deontais Iníochta

Comhairtear na nithe seo ar bhonn íocaíochtaí airgid thirim.

(d) Scéim Aoisliúntais

Feidhmíonn Údarás na Gaeltachta scéim pinsean shochair shainithe a mhaoinítear go bliantúil ar bhunús ioc mar a thiteann amach ó airgead atá ar fáil dó, ar a n-áirítear airgead a chuireann an Roinn Ealaón, Oidhreachta agus Gaeltachta ar fáil agus asbhaintí as tuarastal forne.

Is ionann costas na bpinsean is na sochair phinsean a shaothraíonn na baill foirne sa tréimhse agus léirítear iad mar ghlanchostas, gan na ranníocaíochtaí foirne a choinníonn an tÚdarás. Aithnítear suim comhionann leis an gcostas pinsin mar ioncam sa mhéid is go bhfuil sé infhaichte ar ais, agus go gcuirtear deontais a fhaightear sa bhláin, chun costais phinsean a ioc, ina aghaidh.

Léirítear gnóthachain agus caillteanas achtíireachta a thagann as dliteanas scéime sa Ráiteas Gnóthachan agus Caillteanas Aitheanta lomlán agus aithnítear coigeartú comhfheagrasch sa tsuim infhaichte ón Roinn Ealaón, Oidhreachta agus Gaeltachta.

Léiríonn dliteanas phinsean luach láithreach na n-íocaíochtaí faistíneacha pinsean atá saothraithe ag an bhfoireann go dáta. Is ionann an maoiniú pinsean iarchurtha is an bhunsócmhainn chomhfheagrasch a gheofar sa todhchaí ón Roinn Ealaón, Oidhreachta agus Gaeltachta.

(e) Sócmhainní Dochta

Úsáidtear formhór shócmhainní na heagraíochta i bhforbairt tionscail. Ní bhreathnaítear orthu mar mhaoin infheistíochta agus áirítear iad sa Chlár Comhardaithe ar bhonn costais lúide dímheas carnach.

Áirítear mar mhaoin agus áiseanna tionscláiocha talamh, foirgnimh thionscláiocha críochaithe, áiseanna tionscláiocha, forbairt suímh agus foirgnimh oifige.

Áirítear talamh ar bhonn costais.

Léirítear na sócmhainní eile ar bhonn costais lúide dímheas carnach a áirítear ina ngáláí cothroma bliantúla thar a saolré úsáideach eacnamaíoch measta.

Accounting Policies

Údarás na Gaeltachta Act, 1979

Údarás na Gaeltachta was established on 1 January 1980 under the provisions of the Údarás na Gaeltachta Act, 1979.

The significant accounting policies adopted by An tÚdarás are as follows:

(a) Basis of Accounting

These financial statements are prepared in accordance with section 18 of the Údarás na Gaeltachta Act, 1979 under the accruals method of accounting, except as indicated below, and in accordance with generally accepted accounting principles under the historical cost convention. Financial Reporting Standards as recommended by the recognised accountancy bodies are adopted, as they become operative.

(b) Oireachtas Grants, EU Structural Funds and Grant Refunds and Dividends

These items are accounted for on a cash receipts basis.

(c) Grants Payable

Grants are accounted for on a cash payments basis.

(d) Superannuation Scheme

Údarás na Gaeltachta operates a defined benefit pension scheme which is funded annually on a pay as you go basis from monies available to it, including monies provided by the Department of Arts, Heritage and the Gaeltacht and from contributions deducted from staff salaries.

Pension costs reflect pension benefits earned by employees in the period and are shown net of staff pension contributions which are retained by An tÚdarás. An amount corresponding to the pension charge is recognised as income to the extent that it is recoverable, and offset by grants received in the year to discharge pension payments.

Actuarial gains or losses arising on scheme liabilities are reflected in the Statement of Total Recognised Gains and Losses and a corresponding adjustment is recognised in the amount recoverable from the Department of Arts, Heritage and the Gaeltacht.

Pension liabilities represent the present value of future pension payments earned by staff to date. Deferred pension funding represents the corresponding asset which will be recovered in future periods from the Department of Arts, Heritage and the Gaeltacht.

(e) Fixed Assets

The major portion of the organisation's assets are used to aid industrial development. They are not seen as investment assets and they are stated in the balance sheet at cost less accumulated depreciation.

Property and other facilities comprise land, completed industrial properties, industrial facilities, site development and office buildings.

Land is stated at cost.

All other assets are stated at cost less accumulated depreciation calculated in equal annual instalments over their estimated useful economic lives.

(f) Infheistíochtaí

Léirítear infheistíochtaí i scaireanna ar bhonn costais móide agus lúide soláthar d'athluacháil idir costas agus luach bunaithe ar ghlanluach sócmhainní. Tá clár na n-infheistíochtaí leagtha amach i Nótá 15 agus Sceideal 1 de na ráitis airgeadais seo.

Ní léiríonn na ráitis airgeadais aon chomhdhlúthú ar thorthaí fochuideachtaí ná comhchuideachtaí. Sé tuairim an Údarás go gcuirfeadh comhdhlúthú dá leithéid na cuntais as a rocht, go háirithe nuair a chuirtear san áireamh an éagsúlacht a bhaineann le gnótháí na gcuideachtaí ina bhfuil infheistíochtaí chomh maith le dualgas ginearálta an Údarás féin.

(g) Léasanna

Áirítear na cíosanna ó léasanna oibríocha sna ráitis airgeadais mar a mbíonn siad iníoctha.

Comhairtear an glan-ioncam ó shócmhainní atá ar léas ó institiúidi airgeadais, agus a léasaítear ar aghaidh le client-chuideachtaí, faoi ioncam Eile sa Chuntas Oibríoch ar bhunús fabhraite.

(h) Caipiteal

San áireamh sa chuntas caipítíl tá ioncam a chuirtear i leith cistithe caipítíl agus gach gnóthachan, caillteanas agus athluacháil ar idirbherta sócmhainní agus infheistíochtaí (Nótá 18).

(i) Scéimeanna Fostaíochta agus Sóisialta

Láimhseállan an tÚdarás scéimeanna éagsúla ar son FÁS agus na Roinne Coimirce Sóisialaí. Aithnítear caiteachas ar na scéimeanna seo de réir mar a tharlaíonn sé, agus fabhraítear an t-ioncam gaolmhar sna ráitis airgeadais (Nótá 4 agus 5).

Cost of properties includes an appropriate portion of the site and other infrastructural development costs necessary for the construction of the properties, together with an appropriate portion of the Property and Engineering Division overheads as set out in Note 12.

The depreciation rates applied are as follows:

Property	4% p.a.
Industrial Facilities	3% p.a.
Machinery, Office Equipment and Furniture	10% to 25% p.a.
Motor Vehicles	20% p.a.
Leased Machinery and Equipment	20% p.a.

(or at a rate equal to the income under the lease if this is higher).

(f) Investments

Investments in shares are shown at cost plus and less a provision for the difference between cost and a valuation which is calculated on a net asset basis. Details of the investments are set out in Note 15 and Schedule 1 of these financial statements.

The financial statements do not reflect a consolidation of the results of subsidiary or associate companies. An tÚdarás is of the opinion that such a consolidation would be misleading having regard to the diverse nature of the business of the companies and to the general duty of the organisation.

(g) Leases

Rentals under operating leases are dealt with in the financial statements as they fall due.

The net income from assets which are leased from financial institutions and on-leased to client companies is accounted for in Other Income in the Operating Account on the accruals basis.

(h) Capital

The capital account comprises income applied for capital funding and all gains, losses and revaluations on asset and investment transactions (Note 18).

(i) Employment and Social Schemes

An tÚdarás operates various schemes on behalf of FÁS and the Department of Social Protection. Expenditure on these schemes is recognised as it is incurred and the related income is accrued in the financial statement (Notes 4 and 5).

(e) General Description of the Scheme

The Pension Scheme is a defined benefit final salary pension arrangement with benefits and contributions defined by reference to current "model" public sector scheme regulations. The scheme provides a pension (one eightieth per year of service), a gratuity or lump sum (three eightieths per year of service) and spouse's and children's pensions. Normal Retirement Age is a member's 65th birthday, and pre 2004 members have an entitlement to retire without actuarial reduction from the age of 60. Pensions in payment (and deferment) normally increase in line with general public sector salary inflation.

The valuation used for FRS 17 disclosures has been based on a full actuarial valuation at 31 December 2009. This has been updated to 31 December 2011 by an independent qualified actuary to take account of the requirements of FRS 17 in order to assess the scheme liabilities at 31 December 2011.

The principal actuarial assumptions were as follows:

The mortality basis adopted allows for improvements in life expectancy over time, so that life expectancy at retirement will depend on the year in which a member attains retirement age (age 65). The table below shows the life expectancy for members ages 65 and age 40.
